Mr. Reber noted in this connection that at the present time the Board was receiving most of its intelligence support from State; however, he was looking into this matter and would discuss dissemination of our' productions with Andrews.

Colonel Hansen reported that:


- a. He had passed on to PSB Mr. Dulles' interpretation of the DCI's comments on the Board's participation in a discussion of Psychological Warfare at the American Legion Convention. He stated that PSB is prepared to go ahead with this project, but will not discuss any operational matters.
- b. At his recent visit with Drew Pearson, Pearson had expressed an interest in the activities of PSB and intends to see Gordon Gray in the near future. We may, therefore, expect a column or two on the activities of the Board.

Colonel Taylor briefly discussed Mr. Wisner's trip which will commence on 10 October, and noted that [redacted] will temporarily be assigned to the office of DD/P as [redacted] representative.

Mr. Reber noted that:

- a. Sidney Buford of State [redacted] looked over the G-2 files while there. These files are to be preserved as well as other staff files. In view of this fact, it appears that it will not be necessary for ORR and OCD to send a microfilming team for the purpose of making a permanent record of these files.
- b. He had discussed with Sherman Kent and Dr. Montague Mr. Becker's suggestion that ONE invite OCI to appoint a liaison officer between these two offices. Mr. Larocque stated that in addition to an ONE representative sitting with OCI's Publication Board, there was also an individual from ONE who attended pre-Watch Committee Meetings. In further discussing this matter, Mr. Larocque noted that it was his opinion that CIA should have one voice of authority regarding estimates produced by the Agency to include comments made by OCI in the DIB. He noted that in some instances this responsibility could well be that of the OCI.

Mr. Harvey reported that Mr. Wolf had signed an agreement between CIA, State and Defense regarding support for PSB, and that such administrative support as might be required from this Agency would be furnished through State.
