(TEXT) BROTHER COMPATRIOTS: PRESIDENT MUHAMMAD ANWAR AS-SADAT THIS AFTERNOON INSTRUCTED FOREIGN MINISTER DR MUHAMMAD HASAN AZ-ZAYYAT, WHO IS NOW IN NEW YORK, TO CALL FOR AN IMMEDIATE MEETING OF THE SECURITY COUNCIL TO DISCUSS ISRAEL'S CONTINUED VIOLATION OF THE TWO SECURITY COUNCIL CEASE-FIRE RESOLUTIONS, ISSUED ON 22 AND 23 OCTOBER '73, SINCE ISRAEL IS CONTINUING ITS MILITARY OPERATIONS AND COMMITTING AGGRESSION IN THE SOUTHERN SECTOR WEST AND EAST OF THE SUEZ CANAL.

THE PRESIDENT ALSO INSTRUCTED DR AZ-ZAYYAT TO ASK THE COUNCIL TO CALL ON THE SOVIET UNION AND THE UNITED STATES, IN THEIR CAPACITY AS PERMANENT MEMBERS OF THE COUNCIL AND GUARANTORS OF THE TWO COUNCIL RESOLUTIONS MENTIONED ABOVE, TO EACH SEND FORCES IMMEDIATELY FROM THE FORCES STATIONED NEAR THE AREA IN ORDER TO SUPERVISE THE IMPLEMENTATION OF THE CEASE-FIRE ON THE PART OF ISRAEL AND TO INSURE THAT IT IS EFFECTIVE AND RESPECTED.

PRESIDENT ANWAR AS-SADAT HAS DIRECTLY ASKED PRESIDENT RICHARD NIXON AND CHAIRMAN LEONID BREZHNEV TO SEND THEIR FORCES FOR THIS PURPOSE.

THE PRESIDENT'S INSTRUCTIONS TO DR AZ-ZAYYAT ALSO INCLUDED A (?REQUEST) THAT THE SECURITY COUNCIL REMAIN IN SESSION UNTIL ISRAEL CEASES FIRE AND CONTINUES TO MAINTAIN THE CEASE-FIRE. HE ALSO INSTRUCTED AZ-ZAYYAT TO ASK THE UN SECRETARY GENERAL TO KEEP THE COUNCIL INFORMED OFFICIALLY IN ACCORDANCE WITH THE REPORTS HE RECEIVES FROM THE UN OBSERVATION BODY OR FROM THE SIDES THEMSELVES.

CAIRO COMMENTARY CALLS ON U.S.-USSR TO INSURE CEASE-FIRE

(SAMI HASAN SIRRI COMMENTARY: "THE RESPONSIBILITY FOR MAKING ISRAEL RESPECT THE CEASE-FIRE RESOLUTIONS")

(TEXT) ISRAEL CONTINUES TO VIOLATE THE TWO CEASE-FIRE RESOLUTIONS PASSED BY THE SECURITY COUNCIL, AND IT HAS BEGUN TO HINDER THE ARRIVAL OF THE UN OBSERVATION FORCES AT THEIR WORK POSITIONS ALONG THE CEASE-FIRE LINES. THIS HAS PROMPTED THE EGYPTIAN FOREIGN MINISTRY TO INFORM THE UN SECRETARY GENERAL AND THE UN OBSERVATION ORGANIZATION OF THESE ACTIONS.

IT IS NOTED THAT THE DELAY IN THE ARRIVAL OF THE UN OBSERVATION FORCES AT THE CEASE-FIRE LINES, WHICH HAS BEEN CAUSED BY ISRAEL, IS ALSO BEING EXPLOITED BY ISRAEL, WHICH IS CONTINUING ITS POLICY OF VIOLATING THE CEASE-FIRE RESOLUTIONS AND MOVING ITS FORCES TO NEW LINES, PARTICULARLY WEST OF THE CANAL, WITH THE AIM OF IMPROVING ITS MILITARY POSITION.

THIS ISRAELI BEHAVIOR IS NOT ONLY A VIOLATION OF THE UN SECURITY COUNCIL'S CEASE-FIRE RESOLUTIONS, BUT IT ALSO DISREGARDS THE VIEWS OF THE TWO SUPERPOWERS. IN SO DOING, ISRAEL IS RELYING ON THE U.S. ARMS IT HAS IMPORTED STRAIGHT TO THE BATTLEFIELD.

IN HER STATEMENT TO THE KNESSET YESTERDAY, GOLDA MEIR LINKED ISRAEL'S ATTITUDE WITH THE AID IT HAS RECEIVED FROM THE UNITED STATES. THIS IS DESPITE THE FACT THAT IT WAS THE UNITED STATES WHICH, JOINTLY WITH THE SOVIET UNION, SUBMITTED THE RESOLUTIONS WHICH WERE LATER PASSED UNANIMOUSLY BY THE SECURITY COUNCIL.

SINCE IT WAS THE UNITED STATES AND THE SOVIET UNION WHO SUBMITTED THE CEASE-FIRE RESOLUTIONS TO THE SECURITY COUNCIL, INCLUDING THE GUARANTEES UNDERTAKEN BY THE TWO STATES, THESE TWO STATES MUST BEAR RESPONSIBILITY FOR WHAT THEY SUBMITTED. A SPECIAL RESPONSIBILITY FOR WHAT THEY SUBMITTED. A SPECIAL RESPONSIBILITY FALLS ON THEIR SHOULDERS IN CONNECTION WITH INSURING THE IMPLEMENTATION OF THE RESOLUTIONS AND THE MEASURES PROVIDED FOR BY THE UN CHARTER AGAINST ISRAEL THROUGH THE SECURITY COUNCIL, TO MAKE THAT COUNTRY ADHERE TO THE COUNCIL'S RESOLUTIONS.

CHAPTER SEVEN OF THE UN CHARTER IS QUITE CLEAR IN ITS DEFINITION OF THESE MEASURES. ARTICLES 41 AND 42 OF THIS CHAPTER SPECIFY THE MEASURES AND STEPS THE SECURITY COUNCIL COULD TAKE TO INSURE IMPLEMENTATION OF ITS RESOLUTIONS.

WHILE OUR FORCES STAND VIGILANT AND CAUTIOUS TO PREVENT THE ENEMY FROM ACHIEVING THE OBJECTIVES OF ITS PREMEDITATED CEASE-FIRE VIOLATIONS, WE REAFFIRM THAT THE RESPONSIBILITY FOR MAKING ISRAEL RESPECT THE CEASE-FIRE RESOLUTIONS LIES WITH THE TWO SUPERPOWERS, NAMELY THE UNITED STATES AND THE SOVIET UNION, BECAUSE THEY WERE RESPONSIBLE FOR SUBMITTING THE RESOLUTIONS AND ARE ALSO RESPONSIBLE FOR INSURING THEIR IMPLEMENTATION.
