1. In accordance with your request during referenced conversation, the following message, submitted by you, was transmitted to our N.Y. office, on 17 August 1950:

"We contacted SO immediately and received the following memo which we quote in full for your information and transmission.

1. Subject alleges that he will brief a BNR 'Agent' returning to the USSR when he (subject) reaches Paris in the near future.
2. It is requested that subject be urged to brief the 'Agent' to return with reports on the following subjects or to arrange their transmission through other channels to the BNR representative available to the 'Agent':
  - A. The current strength, organization, activities and status of units or dispersed individuals who compose the BNR resistance force in the USSR.
  - B. The nature, frequency and means of BNR/Resistance Liaison Communications with neighboring resistance forces, allegedly organized in the Ukraine and in the Baltic Republics.
  - C. The identities, locations and activities of leading individuals in the BNR/Resistance.
3. Subject should be pressed to reveal his opinion as to whether wireless transmitting equipment is still available to the BNR/Resistance in the USSR. (Such equipment is known to have been air-dropped into the area in the hands of BNR personnel as part of the German Intelligence Effort in 1944-5). If subject alleges that such equipment is presumed to be available, he can be told that we can develop interest in his organization only on the basis of a successful activation of this equipment without US support. We will monitor any future traffic which subject's 'Agent' may be instructed to activate, thus performing a technical service for subject and, at the same time, enabling ourselves to make a more concrete estimate of subject's capabilities than is possible at present. In subject's briefing of the 'Agent' to activate wireless communications, he will, of course, specify various elements of the wireless plan. Of these, we will have to have the following in order to monitor the traffic successfully during any one month which he specifies:
