

1. 19 FEB   MET AECAMBISTA 4 PER REQUEST LETTER.
2. 4 GENERALLY DISCUSSED REDSOX PLAN HE FORMULATING USING AECAMBISTA 1 ASSETS. HE CONTINUING PERSONAL SURVEY VARIOUS CANDIDATES.

3. AECAMBISTA 4 OFFERING TO KUBARK CIRCA 60KG ORIGINAL BNR DOCS WHICH HE RCVD PER MANDATE FORMER PRESIDENT BYELORUSSIA PLUS CIRCA 70KG RELATED DOCS. ACCORDING 4 ALL OF HISTORICAL SIGNIFICANCE AND INCLUDE SUCH DOCS AS ORIGINAL DIPLOMATIC NOTES BETWEEN LITHUANIAN GOVERNMENT AND SOV EMBASSY LITHUANIA RE BNR IN 18-21. 4 WOULD HAVE NO OBJECTION KUBARK UTILIZATION AND EXPLOITATION THESE DOCS AFTER THEY LOGGED (BY PBPRIME AECAMBISTA 1 REP) AND MICROFILMED. ONLY STIPULATION IS THEY BE SURRENDERED TO FUTURE INDEPENDENT BYELORUSSIAN GOVERNMENT WHICH WOULD BE RECOGNIZED BY PBPRIME. 4 ALSO HAS MANY BYELO BOOKS WHICH HE WILLING TURN OVER FOR BYELO SHELF KUBARK LIBRARY PROVIDED THEY MICROFILMED. 4 FEELS BOTH DOCS AND BOOKS OF HISTORICAL VALUE.
