1. According to information ^{allegedly} ~~reportedly~~ originating in the office of [redacted], the declining state of health of Chancellor ^{Konrad} Adenauer is causing grave concern among his close associates. There is speculation that Adenauer may have to give up his office within six months.

3. In Ruhr circles, Hermann J. Abs, one of West Germany's leading bankers and international financiers, is being considered as a likely ^{candidate} ~~possibility~~ to take over an important position in the West German government. Abs will have the strong backing of West German financiers and industrialists.

2. British circles consider Fritz Schäffer, Minister of Finance, as a possible successor to Adenauer. However, Ruhr financiers oppose Schäffer because of his proposed tax program.
