1. It is FOB's intention not to submit a request for renewal of Project AECHAMP.

2. As Headquarters has pointed out, much of the activity supported by the project is duplicated by other projects. In addition, there is little doubt that the activity involving [] should be discontinued, in view of the unproductivity of this effort. We don't have much hope for [] to develop into a worthwhile operation, either; consequently, there is no need for project AECHAMP to be renewed for this unpromising agent. In the event that [] develops into a substantive operation, a new field project outline will be prepared for him.

3. It is believed that [] should be covered by a project. Rather than request renewal of project AECHAMP for these agents, however, FOB will prepare and submit to Headquarters new, separate field project outlines for []
