Project AECOB

1. It is requested that Project AECOB, which expired on 1 January 1959, be extended retroactive to that date for the purpose stated in Paragraph 2 below.

2. Authorization is requested for the sum of \$10,000.00 under Project AECOB as a death benefit payment to the estate of AECAMBARO/2, an SR/2 contract agent who was infiltrated into the Latvian SSR in May 1954 and was later arrested by Soviet Security forces. The payment of this amount (\$10,000.00) has been authorized by the Office of General Counsel in accordance with the terms of the agent's contract.

3. There are no other outstanding financial obligations under Project AECOB and it is, therefore, requested that the Project be terminated as of 31 January 1963.
