Facts:

The three prospective agents who moved from Sweden to Germany last month are still awaiting the requisite security clearances before they begin operational training. An agent candidate who is qualified to act as a W/T instructor has been selected in the field and clearance for him has been initiated.

Several blind radio transmission were made in an unsuccessful attempt to contact Valdemars, a member of the Latvian Resistance Movement (LRM) who is known to be inside Latvia. Valdemars, who is a personal friend of one of the members of the OPC Latvian operations team in Germany, had devised with him a code by which he could be contacted, directly for LRM communications. Valdemars was returned to Latvia under Swedish auspices in 1948 and has been in contact with the Swedish IS, and through them with OSO since then.
