b. Accomplishments  
There is now no possibility of joint dispatch operations with the British teams spring into the Baltic States. The British plan to run a sea dispatch of three agents into Latvia in April. We are now planning for air dispatch of a team of Latvian agents now in training in Germany this spring. Plans are now being made for future training of Latvian agents to be conducted in the US.
