**a. Mission**

The establishment of clandestine support facilities in the Latvian SSR for the purpose of contacting, organizing and developing agent and underground facilities for the performance of the OPC/OSO missions in the USSR.

**b. Accomplishments**

Contact with leading Latvian emigre figures was continued in order to ascertain feasibility of supporting effort to achieve world wide Latvian unification through holding of a conference in the United States.

An effort is being made to obtain a public declaration by the Department of State to the effect that the United States recognizes O.O. Yurans, member of the Soviet delegation to the General Assembly of the U.N., only in that status and not as Deputy Foreign Minister of the Latvian SSR.
