SUBJECT : Availability of U/W Assets

1. The problem of determining dates when agents held in the US could be ready in wartime to leave the ZI for the European Theater was discussed on 11 January between [ ] of WPS and the writer.

2. On the basis of the line of inquiry presented in OFDA-00288 it was agreed that all that would be needed (to answer OFDA-00288) from the point of view of SR's interests would be an indication that "an agent asset or agent assets" assigned for the coverage of the six U/W areas for which SR Division is responsible can be expected to be ready by D plus 14 for "airlifting from CONUS" to the European Theater. Col. Chandler indicated that further exploration into and study of this problem by WPS has established that it will not be necessary at this time for SR, WE, or EE to go into any discussion of the number of agent assets to be assigned to these targets. I pointed out that C/DOB had indicated to me that, with the continuation and development of project AEDEPOT, additional agent assets have been trained for assignment to these targets since the time of the original U/W requirements exchange (even considering a reasonable attrition rate). However, it was agreed that we would defer until the next time the area divisions have to stand up and be counted against all of the U/W requirements submitted to CIA by JCS before

attempting to determine whether the agents available through AEDEPOT are sufficient in number to permit the assignment of two or more agents to any of these individual targets. (Actually, a total of 49 target areas for the CINCEUR area alone were accepted early in 1959 when the USSR requirements for the various CINC's were presented to SR Division for examination. While some of these were accepted on the basis of assets already trained in AEDEPOT, the majority were accepted on the basis of agents to be trained during FY 1960.) On the occasion of the next formal presentation by the JCS of requirements submitted by CINCEUR, CINCPAC, CINCAL, C/DOB, Colonel Podworny, and the writer can re-examine on an overall basis the statements of capability report sheets prepared last year to see where adjustments on a target by target basis are needed.

SUBJECT : Acceptances of U/W Requirements

- REFERENCES: a. 11 March Memo from Chief, NE Division, FP Staff, same subject (with 2 March draft of Memo from C/FP to DCI and 2 March draft of Memo from DCI to Chairman, JCS)
- b. Memo dated 12 December 1958 from SR/ONE/Plans to Chief, FP Staff, subject: "CIPHER, CIPHERAC, and CIPHERAL Requirements"

1. During this past week I examined reference a., and its enclosures, from the point of view of SR's interests. I found that several items are unacceptable to SR and have informed  of NY/NSA the indicated his agreement with the writer. The reservations which I discussed with Jim are discussed for the record briefly below:

a. "Summary of Acceptances"

On page 2 under the heading "SR", Mandurka is listed showing four requirements with "0" "acceptances". Mandurka is the responsibility of NE Division and is, of course, not part of the U/W.  indicated that this will be adjusted and that the record will show that the "% Accepted" by SR is 100% and not 94% as indicated.

b. 2 March Draft Memo from DCI to Chairman, JCS

The last sentence under para 2 ("However, as a general estimate at this time, we do not believe that this will occur in any substantial number of cases.") is considered by SR to be unacceptable for the following reasons: (1) It is in conflict with the conditions

under which it included the completion of the original  
WV requirements referred to CIA by the JCS. More  
specifically, in BR's 12 November 1958 memo to O/P  
Chair to include in para 3 that BR's assignment  
was based on the assumption that the JCS will be  
induced that any indication of CIA completion of  
individual WV requirements based on the verification  
of the type of work under development in BR's W  
requirements program would be considered an subject  
to subsequent examination by the JCS and possibly  
other agencies outside of the relevant jurisdiction  
for disclosure of CIA work items. As a matter of  
course, this condition was included in paragraph  
of the fact that our former work, which constituted  
"multiple program" work, have been treated previously  
to serve as counterintelligence jobs and, in effect, as  
intelligence collection work although they could  
be used for general or psychological warfare or  
other program including content of questions in  
warfare or campaign in response to National-Secret  
requirements except independently of the military;  
(2) the sentence in question is prefatory and,  
(3) my suggestion that the words in question would  
not be withdrawn from the report of WV requirements  
is in conflict with the language of the para 3, c. and b.,  
(of the proposed memo from BR to JCS) with which BR  
consents without reservation.

2. With the exception of the reservations discussed above,  
the proposed program to the JCS is considered to be entirely  
satisfactory from the point of view of BR's interests. The  
"WV capabilities" checks on requirements in areas within the  
limits are based on the WV Capabilities Reports (para 373)  
3-4 para 1, including in the Warhead and Research to O/P Chair as  
a reference to above referenced 12 November 1958 memo. These  
latest WV Capabilities Report items, which I indicated from  
Mr. Shannon were prepared in 1958 in close consultation with  
the IR Staff, are entirely consistent with BR's earlier submission.  
They are being referred to IR/IND as requested in AI Com's  
11 March memo with a copy of this Memorandum for the Record.
