OFDW-443, 27 July 1962</b></p> <p><b><u>BGFIGHTER</u></b></p> <p>1. <b>BGFIGHTER has developed the following concept for alerting, moving and preparing for the deployment of the CONUS-held UW assets in response to the references. The concept is stated in terms of the preparatory planning tasks which must be completed by Headquarters and BGFIGHTER.</b></p> <p>2. <b><u>Concept</u></b></p> <p><b>A. Headquarters Preparations</b></p> <p>(1) <b>Headquarters will inform BGFIGHTER of team equipment requirements which BGFIGHTER will stockpile in Europe.</b></p> <p>(2) <b>Headquarters will alert and assemble trained assets within 72 hours after a field request for the overseas movement of the assets is received in Headquarters.</b></p> <p>(3) <b>The assets will be assembled under the control of case officers and will be equipped as follows:</b></p> <p>(a) <b>Individual survival equipment</b></p> <p>(b) <b>Communications equipment and signal plans</b></p> <p>(c) <b>Basic counterintelligence and operational intelligence on the appropriate target country or region.</b></p> <p>(4) <b>Headquarters will arrange air transportation for the movement of the assets to the points of overseas reception. These arrangements will be based on transportation requirements which BGFIGHTER has levied on USEUCOM.</b></p>

**B. BGFIGHTER Preparation**

(1) On the receipt of requirements from Headquarters, BGFIGHTER will take action to stockpile team equipment to be prepositioned in Europe at sites selected by BGFIGHTER.

(2) BGFIGHTER has levied on USEUCOM the necessary transportation requirements to secure the movement of the assets to Europe and at the appropriate time will secure a priority from USEUCOM for the movements. (See FALLEX messages for the problems involved in this).

(3) BGFIGHTER will select points of arrival for assets in Europe and will complete arrangements with the appropriate military command to permit entry of the assets.

(4) BGFIGHTER will select holding and marshalling areas in Europe and will complete arrangements with the appropriate military commands to provide housekeeping support.

(5) BGFIGHTER will levy on USEUCOM requirements for infiltration of the assets to the target areas and subsequent resupply missions.

(6) BGFIGHTER will levy on USAFE an appropriate requirement to determine the feasibility of securing flight profiles new to the UW target areas from forward airfields selected by USAFE.

(7) When activated, COMKUBARK FORCE EUROPE will assign the assets to the appropriate KF/EUR Area Commander.

(8) The appropriate KUBARK Force Commander, when activated will provide operational intelligence and staff assistance to the accompanying case officers and their assets.

3. BGFIGHTER will proceed with the tasks outlined above pending approval of Headquarters. Contact with USAFE concerning the air reception points to which the assets may be flown under various circumstances relative to pre-hostilities conditions and after the invocation of the CRA and/or an enemy attack will be explored first.

4. This concept was discussed in detail with   it relates to the AEDEPOTS, during his recent visit to FTX HENKPOINT.
