1. Your attention is invited to the attached memorandum.

2. Note that WFS plans to have meetings with the planning officers of all divisions to discuss the status questions and planning references shown on Attachment 2. Since I will be on military leave on June 14, originally selected as the date for the proposed meeting between WFS and ER representative(s), agreement has been reached between [ ] and myself to set up this particular meeting for 27 June in the office of C/WFS.

3. While WFS is not looking for a formal written response in connection with the questions shown on Attachment 2, there are certain individual questions on which I would appreciate comments from you so that I may have them for reference in my forthcoming meeting. These questions are designated below by number with an indication of the element which should be able to give me comments on which I can rely for any elaboration needed when I meet with [ ] and his staff:

C/ER/SS - questions 2, 5, 7, 8  
C/DOB - questions 3, 4, 11, 12 (?)  
C/ER/6 - question 1

4. It will be appreciated if I can have your brief comment before the middle of June. Actually, I believe I can construct appropriate answers on most of the questions, but in some instances my understanding may be out of date and, in others, I have only a part of the story. I have not included in the above list questions 6, 9, and 10 on which the answers are obvious and would require no elaboration.

**STATUS QUESTIONS AND PLANNING REFERENCES FOR  
SR DIVISION**

1. Have instructions been sent to SR Stations regarding the safeguarding of sensitive documents and disposing of sensitive files?  
(Basic Plan, Page 7)
2. Have plans been prepared for the activation of wartime Headquarters and field organization, either on a full or limited basis, and assignment thereto of Headquarters Staff personnel?  
(Basic Plan, Page 7) (Annex A, Page 9)
3. Does SR maintain a current list of assets for wartime use, and are plans prepared for the activation of such assets?  
(Basic Plan, Page 8)
4. Are techniques and procedures for the conduct of clandestine operations in the SR area being developed?  
(Basic Plan, Page 8) (Annex A, Page 10)
5. Have "alert messages" been prepared for the SR Field Stations?  
(Annex A, Page 9)
6. Have arrangements been made with appropriate theater commander to obtain military unit cover designations where necessary?

7. Has SR prepared estimates of military and civilian personnel mobilization requirements?
