1. AEDOGMA ETA PCS PARI CIRCA 0900 17 AUGUST VIA RAIL. DESIRES RV AFTER ARRIVAL. PLS CABLE DATE PLACE.
2. CONTRARY PARA 5 EGMA 43247 LATE JULY AEDOGMA UPSWING CONTACT ALIAS JUPP SAID PREFERRED AEDOGMA REMAIN MUNI. HOWEVER ASKED AEDOGMA CONTINUE PREPARING REPORTS EMIGRE ACTIVITIES AS BEFORE, NATIONALLY CONCENTRATING PARI AREA. ASKED REPORTS BE WRITTEN PRESS STYLE AND SENT ONCE OR TWICE MONTHLY ACCOMMODATION ADDRESS ASSIGNED AEDOGMA BY JUPP ABOUT THREE YEARS AGO. HANS DURING, MUNICH 37 TA (TELEGRAFENAMT) POSTLAGERND. WILL CONTINUE PAY AEDOGMA BY SENDING MONEY AEDOGMA MUNI BANK. SUM NOT SPECIFIED BUT BELIEVED AS BEFORE.
3. AEDOGMA SUGGESTED TO JUPP THAT AECAPELIN 2 BE UTILIZED AS SUBSTITUTE INFORMANT. TWO WEEKS LATER JUPP REPLIED NEGATIVE, STATING UPSWING NEEDED UN-INTERRUPTED REPORTING AND DID NOT KNOW AECAPELIN 2 RELIABILITY.
