A. AEDOGMA HAS WORKED FOR UPHILL SINCE CIRCA 49 OR 50. CASE OFFICER HAS BEEN UPHILL FOR CIRCA 10 YEARS. CASE ALWAYS HAS BEEN LOOSELY HANDLED AND AEDOGMA CONSIDERED CASUAL INFORMANT. HIS UPHILL SALARY RECENTLY RAISED TO 250 DM MONTHLY. DORBACH CLAIMED HE HAD NO IDEA AEDOGMA ALSO WORKING FOR US. THEY PRESUMED

B. AEDOGMA, LIKE ALL OTHER UPHILL EMIGRE SOURCES, WAS HANDLED

VIRTUALLY WITHOUT UPHILL HQS SUPERVISION UNTIL DORBACH'S EMIGRE DIENSTSTELLE SET UP SEVERAL YEARS AGO. UNTIL THAT TIME, TAKE

FROM AEDOGMA AND OTHERS NOT SYSTEMATICALLY PROCESSED OR CARDED.

JUPP, WHO HANDLED AEDOGMA AND NUMEROUS OTHER EMIGRE SOURCES SUCH AS ARTSYUK, THINKS ALL EMIGRES GREAT, DOES NOT WORRY ABOUT CE ASPECTS, AND CONTENT GET EMIGRE GOSSIP ON REGULAR BASIS, OFTEN BY MAIL.

C. UPHILL KNOWS NO SPECIFIC DEROG INFO RE AEDOGMA. DORBACH

CLAIMS HE HAD BEEN MILDLY CONCERNED BY INDICATIONS AEDOGMA HAD BEEN PUSHING CERTAIN LINES IN HIS REPORTING AND SPECIFICALLY FELT AEDOGMA'S REPORTING ON BANDERA DEATH AMOUNTED TO DELIBERATE WHITEWASH. DORBACH ALSO PUZZLED BY FACT THAT IN 8 NOV LETTER TO UPHILL DROP AEDOGMA REPORTED BASIC OUTLINE AESKEWER STORY, FACT AESKEWER IN
