4. PROJECT DATA:

a. Current objectives.

(1) Project AEPOL covers the following activities directed against the Lithuanian SSR: radio broadcasts, mailing operations, controlled correspondence operations, FP missions for mounted and "piggy-back" REBSEKIN operations, REBSEKIN contact operations in the West, development of operations through emigre organizations, publication or acquisition of propaganda literature for use in REBSEKIN and mailing operations, exploitation of other media such as demonstrations which have FP potential, and conduct of special operations and campaigns as required. In operations conducted through these media the following objectives are being pursued:

- (a) To preserve the national identity of the Lithuanian people thereby helping them to resist assimilation into the Soviet society.

- (b) To maintain among the Lithuanian people an attitude of irreconcilability toward International Communism and the Soviet regime dominating Lithuania today.
- (c) To maintain and enhance the pro-Western and pro-American orientation of the Lithuanian people.
- (d) To encourage revisionist tendencies among Lithuanian Communists.
- (e) To foster evolutionary changes by encouraging the Lithuanian people to seek continuous concessions from the Soviet regime in Lithuania.
- (f) To contribute by all possible means to the growth of intellectual ferment among the Lithuanian people.

(2) Operational mechanisms

- (a) Lithuanian section at Radio Madrid (Radio Nacional de Espana).
- (b) Lithuanian section at Radio Rome.
- (c) Lithuanian section at Radio Vatican
- (d) The Latvian-Lithuanian Union (a largely inactive organization in Western Germany utilized by Frankfurt Operations Base for mailing operations, demonstrations, etc).
- (e) VLIK (a world-wide Lithuanian anti-Communist emigre organization; contact is with the chairman and the secretary of the organization who are in New York).
- (f) FRONTRAS (a world-wide Lithuanian anti-Communist emigre organization; contact is with the chairman of the organization who is in New York).
- (g) Access is possible to various Lithuanian emigre newspapers and periodicals through a journalist contact, [] or through the heads of VLIK and FRONTRAS.

(3) Targets

The target of this project is the Lithuanian people in Lithuania; however, the Russian people are also considered to be an additional target for operations which can be directed at them through the Lithuanian people.

b. Changes in operational mechanism.

- (1) Contact with VLIK was resumed after a two-year interruption. It was agreed that Agency support would be given only for specific operations and not for the over-all activities of the organization.
- (2) New personnel acquired:

□ □ S-3652, 17 July 1959, has been under contract at \$100 per month since 1 August 1959. His primary value is as a writer plus the fact that he has numerous contacts in Lithuanian intellectual circles. He is qualified to prepare broadcast material, to translate and write propaganda pamphlets, to participate in REDSKIN contact operations and to organize mailing and correspondence operations.

- (3) Access to Radio Vatican is again available as a result of our rapprochement with VLIK.

c. Intelligence production.

Intelligence obtained through Project AEPGLE has been of value to REDSKIN operations and has included the acquisition of biographic and travel information as well as of REDSKIN leads themselves.

d. Analysis of effectiveness.

(1) Significant operational events:

- (a) Radio broadcasts were continued from Radio Madrid with a 15 minute original broadcast and a 15 minute repeat per day. Radio Rome broadcasts continued with a 20 minute program per day. An OSI report indicated that reception was technically on a par with VOA broadcasts. Last year a total of 95 reports on Radio Madrid and 60 reports on Radio Rome were obtained from Balts and from Spanish repatriants who had listened to these broadcasts in the Soviet Union.
- (b) Mailing operations from Frankfurt were carried on at an average of 800 letters per month.
- (c) A coordinated campaign involving radio, mail, and emigre leader assets was carried on in connection with the anniversary of the Hungarian Revolution. The campaign was conducted in October and November 1958 and was coordinated with similar Latvian and Estonian campaigns.

- (d) In November 1958 a special mailing campaign was inaugurated which involved a Lithuanian-American girl mailing special material to addresses in Lithuania. From an original mailing of 27 items, correspondence was inaugurated with 12 individuals.
- (e) A letters-to-the-editor campaign was conducted in April 1959 in connection with Khrushchev's offer of a non-aggression pact. Letters from Balts were printed in 10 West German newspapers.

(2) Consonance with Related Missions Directive.

Activities under ANFOLE are in line with Objective 2 under Priority A and Objective 1 under Priority B for the Soviet Union of the Related Missions Directive for Germany.

e. Cover, control and security.

The major cover problem under Project ANFOLE has involved the radio broadcasts. It was determined that substantial improvements in the Lithuanian broadcasts from Rome and Madrid could not be effected until some overt cover organization could be introduced. VLIK was the only logical possibility and negotiations with VLIK were therefore resumed. It was agreed that the Agency would support the radio broadcasts through VLIK. This support is known only to key individuals in the organization. Control over content should remain satisfactory as long as there is no change in the leadership of VLIK. Security should be improved at the radio stations because there will be no need for Agency personnel to contact the assets there. A weakness of this arrangement is the possibility that some member of VLIK could speak of our support; however, such a charge can be denied plausibly.

f. Assessment of indigenous agents.

There is no individual who could be considered a principal agent for this project. Indigenous agents are as follows:

- (1) ANFOLE/25 - is utilized directly by the Frankfurt case officer in Lithuanian mailing operations. Control over him, his motivation and his effectiveness appear to be good; however, there apparently has been only limited initiative displayed on his part.
- (2) ANFOLE/21 - has had occasional contact with the Frankfurt case officer who recruited him, receives his pay from the [] and receives his guidance from Headquarters. His

effectiveness and motivation appear to be good. Control is based on his dependence on Agency financial support plus common anti-Communist interests. He has responded enthusiastically to Headquarters guidance.

- (3) AEPGLE/22, AEPGLE/26, AEPGLE/27 - have had occasional contact with the Frankfurt case officer who recruited them. They receive their pay from the [] through a cutout. Guidance is sent from Headquarters. Effectiveness and motivation appear to be fair. Control has been adequate and they have responded favorably to Headquarters guidance.

g. American project personnel.*

(1) Headquarters

*All case officers and the career agent spend from one-fourth to one-third of their time on Project AEPGLE.

**The contract agents are on a part-time basis and receive from \$100 to \$120 per month. It is anticipated that two of them will be dropped by the end of FY 1960.

h. Liaison with intelligence services.

There has been no liaison with any intelligence services.

i. Interagency coordination.

No interagency coordination has been required.

j. Plans for ensuing year.

- (1) It is anticipated that there will be a great increase in travel to and from Lithuania in the coming year based on the following information:

- (a) Vilnius has been opened to foreigners for travel;
- (b) There has already been an increase this year in the number of Soviet Lithuanians traveling to the West;
- (c) Construction of tourist facilities in Lithuania has been reported;
- (d) A Soviet Lithuanian official announced that the University of Vilnius would soon accept non-Communist Lithuanians from abroad for study at the University.
- (e) A Soviet Lithuanian diplomat announced that the U.S. citizenship of Lithuanian-born Americans would soon be recognized.

Because of these facts which promise an increase in REDSKIN operations, the SA/2 Baltic Section is preparing to shift its FP effort to place major emphasis on the FP aspects of REDSKIN operations.

(2) REDSKIN operations

These operations will be handled in close cooperation with the FI personnel of the Lithuanian desk. Operations are planned to be mounted from both the United States and Western Europe. Emphasis will be on case officer briefing of travelers although agent assets and emigre organization contacts will be used for "piggy-back" operations and for contacting Soviet Lithuanian travelers to the West.

(3) Radio operations:

It is expected that there will be a further improvement in the quality of the broadcasts from Radio Rome and Radio Madrid. Radio Vatican will supplement our propaganda capability as soon as negotiations are completed with VLIK and we are able to analyze the potential of this station. With VLIK providing the necessary cover we will be able to add special features and obtain better information on audience reaction. It is planned to eliminate eventually all Agency contact with assets at the radio stations and to handle all guidance through VLIK; this would strengthen the cover and security aspects of the broadcasts.

(4) Emigre organization activities

It is planned to utilize our contact with VLIK for specific operations to include REDSKIN spotting, REDSKIN contact operations, support of radio broadcasts, demonstrations, political action and similar activities. In addition, we plan to contact selected leaders in the Lithuanian youth organizations, Santara and Ateitininkai, for similar purposes.

(5) Controlled correspondence operations

It is planned to develop controlled correspondence operations utilizing Lithuanian youth, students and intellectuals to achieve eventual REDSKIN operations and to get FP material into Lithuania as well as to obtain biographic, postal and other information.

(6) Mailing operations

- (a) Mass mailing operations will be continued at one-fourth the level for FY 1959 (about 250 letters per month). Headquarters will continue to furnish the texts for these letters and will attempt to obtain a more selective approach.
- (b) Special campaigns such as the letters to West German newspapers concerning Khrushchev's statement on a non-aggression pact will be conducted when feasible.
- (c) The use of Soviet Lithuanians to distribute Russian language propaganda material is being investigated.
- (d) An operation involving printing in the West and periodic mailing from inside Lithuania of a pamphlet ostensibly coming from a liberal intellectual group or a strongly nationalistic group is under study.

(7) Special campaigns

A coordinated campaign involving radio, mail, traveler, emigre organization, emigre press and agent assets is planned in connection with the twentieth anniversary in 1960 of the Communist takeover in Lithuania.

- (a) Salary increases to agents did not cover the whole of 1959 whereas they will do so in FY 1960.
- (b) Increased funds are required for REDSKIN operations for purpose of travel, purchase of information, obtaining printed material for distribution to Soviet Lithuanians, etc.
- (c) Funds are required in support of a special campaign on the twentieth anniversary of the Communist take-over in Lithuania.


