2. SUBJ ACTED PRIMA DONNA ROLE AND REFUSED PASS ANYTHING BUT MOST  
MEAGER INFO, SAYING SHE FELT IF SHE TOLD ALL SHE KNEW NOW SHE MIGHT NOT  
BE ABLE GET INTO US. SAYS SHE EXPECTS US VISITOR'S VISA ANY DAY. APPEARED  
TRYING USE HER INFO INFLUENCE US GOVT INTO GIVING VISA.

3. LOCAL LITHUANIAN WITH WHOM SUBJ RESIDES LATER CONFIDED TO  
[ ] THAT SUBJ ACTING ON INSTRUCTIONS LITHS IN US WHO TRYING ARRANGE  
VISITOR'S VISA FOR HER. [ ] AND KIZYTE MENTIONED AS PERSONS WHO ADVISED  
HER NOT REVEAL ANYTHING TO ANYONE IN EUROPE AND THAT SHE WOULD BE PUT IN  
TOUCH WITH US INTELLIGENCE OFFICIALS WHEN IN US.

4. FROM MEAGER INFO ABLE GLEAN FROM SUBJ, (PORTION GARBLED-BEING  
SERVICED) SHE VORTHWHILE BRING CABEZONE FOR DEBRIEFING. NOTED HOWEVER  
SHE NOT VERY OBSERVANT AND HAS NO KEEN INSIGHT INTO SOVIET POLITICAL  
AND ECONOMIC AFF/IRS.
