3. SINCE SAFEHOUSE UNWARRANTED FOR INFREQUENT MEETINGS WITH AECAMBISTA 4, 11, 15, ETC MOB CASE OFFICER CONDUCTS MEETINGS EITHER AT RESTAURANTS OR IN OPS (GERMAN LICENSE) VEHICLE.
