1. Upon the departure from CSOB of  assumed accountability for 50,000.00 roses originally drawn by   as part of the technical support for AECARTHAGE 12 and 13, who exfiltrated into the Soviet Union in 1952.

2. It is requested that authority be given to write off this accountability. Reasons are as follows:

A. Mission of neither agent included his return to the West. Both were charged as trained W/T operators to remain with AECAWNPORE Headquarters and to function there as indispensable communications experts.

B. Subsequent W/T traffic from AECARTHAGE 12 and AECAWNPORE Headquarters, with whom AECARTHAGE 13 was associated, indicated the roses had been consumed and requests for additional amounts were made (MUNI-4953, para 1B, 19 August 1953; MUNI-5549, para 1B, 9 October 1953).

C. AECARTHAGE 12 was surprised during his last W/T contact in 1953 and may have perished (MUNI-6004, 30 November 1953).

D. AECARTHAGE 13 fell in action (MUNI-5549, para 1B, 9 October 1953).

3. A unicip copy of receipt signed by AECARTHAGE 12 and 13 is forwarded under separate cover.
