SUBJECT: Meeting with AECASSOWAFY 2

1. On 14 Sept. undersigned met with AECASS 2 ~~him~~ at his home in New York. Matters discussed were as follows.

a) the "black radio" broadcast under AECASSOWAFY/EP. ~~in~~ ~~making~~

~~in~~ AECASS 2 and his colleagues ~~to~~ involved in making tapes for the black radio broadcasts encountered some difficulties in cutting tapes when they tried to record the identification theme and background music. Because of this, AECASS 2 requested that we supply him with some technical personnel to help make the tapes. Cass 2 was told this could not be done since AECASS 4 already knew enough to cut tapes and that sooner or later they would have to go it alone as per agreement. The undersigned advised AECASS 2 ~~that~~ his problem of cutting background music and identification theme could be overcome by the use of two phonographs to be operated by CASS 4 who also operates the other apparatus during the cutting of tapes. This seemed to be the answer to their problem. If it works, finished tapes should be coming off the assembly line within two weeks.

b) Radio scripts. The undersigned advised Cass 2 that it ~~would~~ *will* be necessary to have the scripts translated into English, and that since CASS 15 has the time, he should begin translating scripts even though the translations might not be in the best English. Cass 2 said he would make the necessary arrangements with CASS 15.

c) Aid to the ZCh. Cass 2 stated ~~that~~ he was advised by AECAVATIFA 5 that SBYCP A would support the ZCh at the rate of 6000 DM for the month of Sept. and beginning Oct. and continuing indefinitely at the rate of 5000 DM. Originally, SBYCPA was going to cut off its support on 1 Sept. No explanation was given why the support is to continue.

d) Messages from AECAVATIFA 11 (Miron); Aecass 2 advised that he received a portion of a message from Pidhainy as sent by Miron in which the Miron states he is attempting to make contact with ~~Demish~~. Cass 2 claimed this to be all that he had gotten from ~~Pidhainy~~.

e) Other. Presently, AECASS 2 is working on an analysis of past and current operations in the Ukraine, both ours and SBYCPA's. When completed, he will submit a copy ~~for information~~ to us for our information.

f) Cass 2 ~~mentioned~~ wanted to know whether a person in Cardad (not ~~necessary~~ a citizen) could come to the US to work. (He had in mind an Ukrainian suited for Study Group activity.) The Undersigned said he would look into the matter. He also wanted to know whether we could help another prominent Ukrainian emigrate to the States from a country in South America and who could also be used in connection with the Study Group. (This person is Halaichuk, considered an authority on International Law)
