REDWOOD AEVIRGIL AERODYNAMICS -> file

1. AEVIRGIL 4 BROUGHT FROM BERLIN TWO PIECES FABRIC CONTAINING HAND WRITTEN MSGS FROM UKRAINIAN NATIONALISTS IN SOV PRISON CAMPS. FIRST IS OPEN LETTER TO UNITED NATIONS ATTACKING COMMUNIST RUSSIA BEHALF AUTHORS AND UKRAINIAN PEOPLE SPECIFYING ABSENCE ELEMENTARY RIGHTS FOR UKRAINIANS, TRANSFER UKE SOLDIERS AWAY FROM UKRAINE, NEW CAMPS AND CITIES BEING BUILT ON MASS GRAVES SIBERIA TO HIDE TRACES GRAVES, MASS SHOOTINGS IN CAMPS DURING DEMANDS FOR MINIMUM RIGHTS 53, 54. ACCOMPANYING RESOLUTION DEMANDS INVESTIGATION CAMP CONDITIONS, REMOVAL RUSS/ANS FROM UKRAINE UNTIL GENOCIDE, ASSIMILATION, UKE OPPRESSION STOPPED. DOCS SIGNED WITH INITIALS, PSEUDOS LEADERS FIVE FEMALE EIGHT MALE PRISONER GROUPS.

2. SECOND FABRIC IS LETTER TO UKE FRIENDS ABROAD TELLING WHAT SOV PROPAGANDISTS SAY RE UKE EMIGRATION OF LAST DECADE AND RE FATE UKES IN POST WAR CAMPS. SAYS INMATES REFUSE BELIEVE SOV LIES ABOUT WEAKNESS, SPLITS, STRUGGLE FOR POWER IN UKE EMIGRATION, BELIEVE EMIGRES ARE FULFILLING TASK SET BY THE PEOPLE OF UKRAINE IN PREPARING

LIBERATION UKRAINE. SECOND PART SAYS INMATES "RELEASED" UNDER SO CALLED EASING OF CONDITIONS SENT INDEFINITE TIME SIBERIA. SAYS RECENT AMNESTY NOT APPLIED TO UKES WHO CALLED BANDERITES OR UKE GERMAN NATIONALISTS.

3. DOCS GIVEN AEVIRGIL 54 NOV 22 BY GERMAN WOMAN KAROLINE X HLZ RECENTLY RETURNED FROM USSR WITH GERMAN PWS. CLAIMS SHE ENTRUSTED WITH THEM BY UKE WOMEN IN VORKUTA, SMUGGLED OUT IN QUILTED JACKET. BROUGHT MUNI BY AEVIRGIL 4 AND SHOWN SEVERAL AEVIRGILITES.

4. CONTENTS MAKE MATERIAL UNSUITABLE AEVIRGIL 1 EXPLOITATION BUT SEE DEFINITE POSSIBILITY USE UKE GROUPS. PROPOSE SHOW ORIGINALS AECASS 3 AND 6 WHO HAVE HAD RECENT EXPERIENCE INTERVIEWING RETURNEES FRIEDLAND AND CAN EVALUATE CONTENTS. THEY WILL BE ENJOINED AGAINST ANY DISCUSSION THIS MATERIAL.

5. PLAN POUCH ORIGINALS PLUS AECASS COMMENT HQ SOONEST.

6. REQUEST BRLN QUERY AEVIRGIL 45 FOR FULL DETAILS RE SOURCE, ORIGIN DOCS, AND CIRCUMSTANCES HER ACQUISITION. PLS ADVISE IF SHE AVAILABLE FOR INTERROGATION. CABLE SUMMARY POUCH DETAILS MOB AND HQ.
