Headquarters action required:

1. Answer to paragraph two of reference is again requested.

Developments

2. Discrepancies in accounting for AECASSOWARY 1 and AEDRUMMER newspaper subsidies were pointed out to AECASSOWARY 6 (neglecting to carry over profits from preceeding to succeeding months) and it was urged that accumulative profits dating from September 1954 be shown in the next accounting submitted by AECASSOWARY 3.
3. Lyubovr ORTINSKYI received a letter from Joseph KNUITY in which the latter made a strong appeal to ORTINSKYI to return to the Homeland and while still in the West, to use his influence with other Ukrainian journalists to curtail their anti-Soviet writings and other efforts at hindering the work of the Return to the Homeland Committee. (See EGMA-22732).
4. Through mail intercept, it was learned that AECAWNPORE 4's son had communicated with a certain Frenchman, now in France, with whom he had become acquainted in a Soviet prison. Since the Frenchman had returned home, AECAWNPORE 4's son is seeking the Frenchman's help in locating an aunt who is possibly living in France. Without revealing the source of this information, this was made known to AECASSOWARY 6 who showed great interest in the matter since, as he explained it, the Frenchman might be able to provide some clues as to AECAWNPORE 4's death. (It had been reported by other unknown sources - returned PW's - that when AECAWNPORE 4 was killed, the Soviets brought his son from prison to Western Ukraine to confirm his identity). The undersigned told AECASSOWARY 6 that every attempt will be made to put the AECASSOWARIES in touch with the Frenchman.

5. AECASSOWARY 6 reported that the committee selected to exploit the HILZ documents has not met with too much success, mainly because most think AECASSOWARY 2 has already done alone (presenting the documents to the United Nations) what the committee is now trying to do. Another factor in the lack of progress by the committee is the negative attitude shown by the UNR and URDP who have boycotted the committee meetings because of their resentment to the way the documents were originally made public.

6. Of possible significance in the case of Yuriy KAPUSTINSKYI, who was apprehended by CIC while making a pitch to Modest RIPETSKYY in March 1956 for the RIS, is the fact that AECASSOWARY 6 learned from a Dr. Volodymyr VOYTOVYCH, a veterinarian from Mark Obersdorf, that there are two KAPUSTINSKYI brothers (fn's unknown) now in the states while a third brother, Yuriy KAPUSTINSKYI, allegedly died near Brody, Ukraine while serving with the Ukrainian "Galicia" division during WW II. It should be noted that KAPUSTINSKYI, while writing his signature on several different occasions, misspelled his name. Thus, it is very possible that KAPUSTINSKYI is not the true KAPUSTINSKYI but is merely using the legend of this person.

OPERATIONAL MATTERS AND COMMENTS:

1. The undersigned visited AECASSOWARY 6 at his safehouse in order to be present when a delivery of furniture was made by a crew of Germans working for Army QM. The new furniture was installed without incident.

2. While waiting for the furniture to arrive, the undersigned explained to AECASSOWARY 6 a discrepancy in past newspaper accountings (neglecting to carry over profits from preceeding months to succeeding months) and urged that the accumulative profits dating from September 1954 be shown in the next accounting of the AECASSOWARY 1 and AEDRUMMER papers. To make certain that the correct total figure was used, a list of all profit shown in their accountings dating back to Sept. 1954 was given AECASSOWARY 6.

3. The undersigned returned the press clippings on the ~~HILZ~~ documents (clipped from the German press) and informed AECASSOWARY 6 that photo copies had been sent to headquarters with a request that they be made available to AECASSOWARY 2 for his use. AECASSOWARY 6 said that more clippings have been received by his organization and that these will be made available for our edification.

OPERATIONAL MATTERS AND COMMENTS:

1. AECASSOWARY 6 phoned the undersigned at about 0900, 10 August 1956 and said he had something interesting to pass. The undersigned requested that AECASSOWARY 6 meet him at 1030 at a cafe (located on the road to Grunwald) rather than hold the meeting at the 15 Geibelstr. address. (The undersigned had another meeting scheduled for later in the day and therefore was a bit pressed for time.)

2. At the 1030 meeting, AECASSOWARY 6 produced a letter he had gotten from Lyubomyr ORTINSKYI which the latter had received from Joseph KRUTIIY. (This letter was sent to headquarters in EGMA-22732). The letter was mailed from East Berlin and contained in it, among other things, a request that ORTINSKYI return to the Ukraine as KRUTIIY had done. The letter contained two return addresses (in the letter itself), one in East Berlin and the other in Kiev. AECASSOWARY 6 said that AECASSOWARY 8 had also received a letter from KRUTIIY.

3. AECASSOWARY 6 requested that the letter be shown to AECASSOWARY 2; who has maintained an interest in the KRUTIIY defection and his subsequent actions regarding an attempt to lure back to the homeland key Ukrainian emigre personnel.

4. COMMENT: Our local mail intercept channels produced a copy of the above mentioned letter on 8 August 56.

5. AECASSOWARY 6 mentioned that the HILZ documents, publicly released on 20 and 24 July, were still being publicized by both Ukrainian and other papers. He said that certain Viennese papers had devoted much space to the HILZ documents. AECASSOWARY 6 said he would furnish us with clippings in the near future.

OPERATIONAL MATTERS AND COMMENTS:

1. Since the undersigned was pressed for time, he requested AECASSOWARY 6 to meet him at a cafe. During the ensuing lunch, the following business was transacted:

a. Returned to AECASSOWARY 6 the letter Lyubomyr ORTINSKYI received from Joseph KRUTYI and told him that the original was sent to Headquarters with a request that it be shown to AECASSOWARY 2. The undersigned told him that a comparison of the handwriting with other KRUTYI script showed the letter was written by KRUTYI.

b. The undersigned told AECASSOWARY 6 we learned recently that a Frenchman (see EGMA-22737) who once served in a Soviet prison camp with the son of AECAWNPORE 4 received a letter from Yuriy (AECAWNPORE 4's son) in which he asked the Frenchman to help him locate his aunt. AECASSOWARY 6 showed great interest in the news and requested that we try to obtain additional information about the Frenchman and whether we could arrange for one of the AECASSOWARIES to debrief the Frenchman. AECASSOWARY 6 felt that the Frenchman could shed some light on the death of AECAWNPORE 4, etc. The undersigned told AECASSOWARY 6 he would do what he could in this respect and would let him know.

c. The undersigned asked AECASSOWARY 6 about the results of the meeting held by the committee selected to exploit the HILZ documents. He said that nothing conclusive was decided since there was much discussion on the action to be taken. He said that the UNA and URDP did not attend the meeting. He said the committee is to meet again in about a week.

d. AECASSOWARY 6 gave the undersigned two Return to the Homeland Dnipro letters received recently by ORTINSKYI and HARABATSCH, Eugene. He pointed out that the address of HARABATSCH was taken from the Herderbund rolls for the address on the envelope was written exactly as the Herderbund had it recorded and exclusively used it.

CONTACT REPORT No. 4

SUBJECT: Contact with AECASSOWARY 6 on 28 August 1956

1. As pre-arranged by [] the undersigned telephoned AECASSOWARY 6 on the morning of 28 August 1956 when A/6 requested a meeting with the undersigned. A/6 passed a number of recent editions of various emigre publications which publicized the two letters which were smuggled out of Soviet concentration camps.

2. A/6 also passed another form letter which Volodymyr BORYS received from "Dnipro", the Ukrainian branch in Germany of the East Berlin Committee for the Return to the Homeland. This latest form letter attacks the BANDERA clan and its propaganda campaign, exposing supposedly secret aliases or pseudonyms, for instance, "Baba" "Byylykho" "Siryy" (used by Stepan BANDERA), "Kach" and "Kasbovych" (used by Yaroslav SPETSKO), "Bahryany" and "Dzhyhut" (used by Ivan KOZOVYAHYN, better known in the emigration as Ivan BAHRYANYI), "Klishch" (used by Lev REBET) and others which the letter does not mention.

3. A/6 made various comments concerning the recent TsESUS (Central Union of Ukrainian Students) at which Dmytro ANDRIYEVSKYY (OUN/M figure) made various derogatory attacks at various Ukrainian emigre establishments. (A/6 passed a mimeographed copy of ANDRIYEVSKYY's address). A/6 also mentioned the obituary of Lyuba MATVIYEVKO nee DANYLYUK, stating that, in a conversation with Dr. Volodymyr VOYTOVYCH, a veterinarian who lives at Mark Obersdorf (near Kaufbeuren), the latter mentioned that a KAPUSTINSKY family came from the same neighborhood as the deceased Lyuba MATVIYEVKO. A/6 further learned that two KAPUSTINSKY brothers (fn's unknown) have emigrated to the United States while the third brother, Yuriy KAPUSTINSKY, died near Brody, Ukraine, while serving with the Ukrainian "Galicia" Division during World War II. A/6 stated that MATVIYEVKOs come from Kaminka-Staumilova, Ukraine. A/6 added that she was married to fn PYTLIK, brother of Bohdan PYTLIK (now in Munich) who repatriated to the Ukraine GSR during circa 1946-47; the repatriated PYTLIK wrote Lyuba as late as 1948, asking her not to re-marry. However, she married Vasyl MATVIYEVKO (brother of Myron MATVIYEVKO, who was dispatched to the Ukraine circa 1951 by the BANDERAITES) in circa 1948-49.

4. The above information is of possible interest in the case of the Yuriy KAPUSTINSKY who was apprehended by CIC while making a pitch in behalf of the RIS to Modest RIPETSKYY during March 1956. It is noted that KAPUSTINSKY, while writing his signature on several different occasions, misspelled his name each time. From this, the possibility exists that KAPUSTINSKY is not the true KAPUSTINSKY and is using the legend of this person.
