1. BAVARIA LfV (SCHACHINGER ACTING DURING ABSENCE RIEDMAYR) INFORMED ALONG LINES REF. DISCUSSION DEVELOPED WITH SCHACHINGER, CHIEF EVALUATION SECTION, HUBER, EVALUATION CHIEF FOR EMIGRE ORGANIZATIONS, SCHREIEDER, CE IN OPS SECTION, ALL OF LfV AS FOLLOWS:

A. LfV THANKED US FOR DEFINITIVE STATEMENT RE ODYOKE INVOLVEMENT BANDERA. CLAIM THEY ALMOST CERTAIN WE WERE NOT INVOLVED (SUSPECT SMOTH INVOLVED).

B. HUBER STATED RIEDMAYR TOO RESTRICTIVE IN STATEMENT TO ME. THEY ALSO WANTED STATEMENT RE UHVR AND OUR INVOLVEMENT WITH THEM.

C. REPORTEDLY LfV AMASSED CONSIDERABLE DATA ON UHVR. THEY CLAIM ALMOST CERTAIN THAT SOME ELEMENT OF ODYOKE INTELLIGENCE IS BEHIND UHVR (LOCATED KARLSPLATZ NUMBER 9, THIRD FLOOR, MUNICH).

D. THEY CLAIM UHVR INTELLIGENCE ACTIVITIES CONSIDERED IN SAME LIGHT AS BANDERAS. ONLY DIFFERENCE ALLEGED TO BE MORE TEMPERATE UHVR

ATTITUDE IN VIEW ODYOKE SUPPORT; OTHERWISE CONSIDER ONE NOT BETTER THAN OTHER. CONSIDERABLE COMPETITION IN INTELLIGENCE FIELD ARISEN BETWEEN OUN-B AND UHVR; A NUMBER FORMER BANDERAITES NOW IN INTELLIGENCE BUSINESS FOR UHVR WHICH ATTRIBUTABLE TO UNHEALTHY COMPETITION.

E. IN VIEW ABOVE IF ODYOKE REPORTS NO INVOLVEMENT LfV WANTS REPRESENTATION MADE BY BAVARIAN GOVT TO FED FOREIGN OFFICE WITH VIEW TO CURTAILING UHVR INTELLIGENCE ACTIVITIES FROM BAVARIAN SOIL (SAME AS BANDERA). ON OTHER HAND IF WE ADVISE WE INVOLVED HUBER CLAIMS LfV WILL BE SATISFIED AND NO REQUEST FOR ACTION WILL BE MADE.

2. LfV CERTAIN BANDERA GROUP DISPATCHING COURIERS TO SOVIET ORBIT. SCHREIEDER CLAIMS HE IN TOUCH WITH A TOP MAN IN BANDERA GROUP. THIS CONTACT PLUS OTHER INFORMATION COMING TO THEIR ATTENTION LEAVES NO DOUBT SPRING 56 OPERATION WAS LAUNCHED; PERSONNEL IN TRAINING AT THIS TIME; OPERATION PLANNED FOR NEAR FUTURE.

3. QUERY RE UHVR COULD CERTAINLY BE PROVOCATION. NOTHING TO PREVENT THEM ASKING FOR SIMILAR STATEMENTS OTHER ORGANIZATIONS IN FUTURE. WHETHER FOREGOING ACCURATE OR NOT DENIAL OF TRUTHFUL STATEMENT COULD RESULT IN EMBARRASSING SITUATION. LfV REPRESENTATIVES WOULD NOT GIVE OUT ADDITIONAL
