1. EXELF CONTACTED 12 FEB BY (FNU) VOSKOVICH WHO IDENTIFIED SELF AS  
*YAROSLAV STETSKO*  
REPRESENTATIVE OF (FNU) ~~STETSKO~~, LEADER OF FREE UNRAINIANS. STATED ORGANIZATION  
HAS PREPARED FOUR AGENTS FOR WORK IN WESTERN UKRAINE AND NOW SEEKING MEANS  
INFILTRATE THEM TO TARGET AREA. REQUESTED TURK APPROVAL AND ASSISTANCE TO  
DISPATCH VIA TURKEY.

2. EXELF ASKED WHETHER AGENTS PROVIDED WITH NECESSARY DOCUMENTS AND  
RECEIVED NEGATIVE REPLY. E THEN EXPRESSED VIEW THAT LONG TRIP THROUGH CAUCASUS  
WITHOUT DOCUMENTS DOOMED TO FAILURE. VOSKOVICH REPLIED HE THINKING MORE IN  
TERMS BLACK SEA ROUTE BY BOAT OR POSSIBLY BY BALLOON. WHEN EXELF SAID HAD  
NO EXPERIENCE OR CAPABILITY WITH LATTER, V SUGGESTED HE POSSIBLY COULD ARRANGE  
ODYOKE ASSISTANCE FOR THAT ASPECT OPERATION. EXELF AGREED EXAMINE PROBLEM  
FROM VIEWPOINT EXCAP AND MEET AGAIN 15 FEB.

FURTHER EXPLORATION ALLEGED AGENT ASSETS? WOULD KUBARK BE INTERESTED SUPPORTING
