2. URGE FIELD CASE OFFICER INVESTIGATE POSSIBILITIES OF RESETTLING DISPOSAL PERSONNEL WITH OTHER ORGS IN FEDREP. SUGGEST YOU CONTACT [] MOB LIAISON OFFICER, TO LEARN WHETHER PECHORD, TPLINGO, TPFEEKING, JCGREOLE BGCALLUS, OR OTHER ORGS COULD ABSORB SOME OF THE MORE QUALIFIED.

3. PER REF B, RE ENTRY EMPLOYMENT UNDERSTANDING, GIVE ONE MONTH TERMINATION NOTICES AS OF 1 AUG 1957. WE ARE PREPARED TO EXTEND UP TO THREE MONTHS TERMINATION PAY TO INDIVIDUALS ON BASIS OF NEED, CASE BY CASE. HOWEVER, IT WILL BE FIELD'S RESPONSIBILITY TO JUSTIFY PAYMENT OF FUNDS AFTER 1 SEPT 1957
