Operational Matters and Comments:

1. Subject indicated that on the day of AECASSOWARY-3's departure from Munich to Bremerhaven (and thence to the United States), Yuriy STUDYNS'KYY visited AECASSOWARY-3 and, in the presence of AECASSOWARY-6, made inquiries concerning AECASSOWARY-3's itinerary and even noted the latter's auto license plate number. Following AECASSOWARY-3's departure STUDYNS'KYY tried very hard to ingratiate himself with AECASSOWARY-6, going so far as to invite AECASSOWARY-6 out for a drink (which STUDYNS'KYY never did before). AECASSOWARY-6 politely refused.

2. Then, several days after AECASSOWARY-3's departure, STUDYNS'KYY's sister, fnu, married to Dr. fnu ~~STISOVSKYY~~ (latter now in the USA) came from Vienna to Munich and immediately went to AECASSOWARY-3's residence. She asked the landlady to admit her into AECASSOWARY-3's quarters, acting as though this were commonplace. The landlady, of course, refused to let her get past the main entrance.

3. AECASSOWARY-6 had no further information but issued his suspicion concerning STUDYNS'KYY's strange behavior and noted that aside from the fact that STUDYNS'KYY may have been acting in behalf of ZCh/OUN/BANDERA it was possible that STUDYNS'KYY "may be working for the other side". He said he would call if he obtained any further information.

4. AECASSOWARY-6 also passed a photograph of an unidentified man who speaks Ukrainian and who has been visiting all Ukrainian emigre offices and publishing houses in Munich. (The photograph was taken in front of the local Ukrainian Catholic Church.) The man refused to identify himself when he was politely and discretely asked to do so at the offices of AECASSOWARY-1. (It is planned to show the photograph to AECAPELIN-1 for purposes of identification.)
