1. Paragraph 1 of reference has been brought to the attention of AECASSOWARY-3 who promised to supply us with the information regarding the newspaper personnel as requested. This will be transmitted when received from him. It is expected that his newspaper accountings, if ready by the time he submits his personnel report, will also be submitted for transmittal to AECASSOWARY-2. Future accountings will be handled as prescribed in reference dispatch.

2. With respect to paragraph 2 of reference dispatch, AECASSOWARY-3 reported that to date AECASSOWARIES have done nothing on their own in mounting certain action at the Brussels Fair. However, AECASSOWARY-3 pointed out that in concert the Ukrainian community through its various church membership has made plans to disseminate certain Ukrainian scholarly and church publications via space afforded them by the Vatican pavilion at the fair. Currently, this action is being coordinated by Rev. Yakiv ERRIDON, the Apostolic Visitor for Holland and Belgium, who lives in Wilhelminaplein, Holland. Further, AECASSOWARY-3 reported that Dr. Vasyly MARKUS of Paris, France and who has connections in Brussels among businessmen there, has been investigating possibilities of disseminating Ukrainian literature through one of a number of local bookstores outside the fair grounds but during the time of the fair. AECASSOWARY-3 said that AECASSOWARY-2 is aware of MARKUS' activity and should be in a position to furnish headquarters personnel with additional details about this.

3. AECASSOWARY-3 said he has been communicating with AECASSOWARY-2 on the problem of taking some propaganda action at Brussels but that nothing concrete has been decided upon yet. He went on to point out the difficulties involved, considering that space at the fair, that is, a pavilion or booth, would be next to impossible to get and that to operate out of a fixed installation they would have to impose on others for this as in the case of the Vatican pavilion. In any case, AECASSOWARY-3 said he would

recommend that when the fair opens AECASSOWARY-6 visit it for the purpose of determining what means might be open for carrying out some action. Here, [redacted] suggested, in the event no permanent booth, etc. is obtained, that AECASSOWARY propaganda be printed on book matches (language to be determined) and these matches distributed free of charge by AECASSOWARY representatives who could work the streets, so to speak, handing out the matches to fair visitors. Whether permission would have to be obtained from Fair authorities to do this or whether this would have to be done surreptitiously is something that would have to be determined. Nevertheless, AECASSOWARY-3 thought this idea had merit and said he would probably take this up with AECASSOWARY-2.
