1. A sum of Deutsche Mark equivalent to [] (computed at the current purchase rate used by CIA) will be handed over to a representative of an anti-Soviet group currently being used by OPC and OSO. A responsible representative of that group shall receipt for the lump sum over his signature.
2. It is desirable that the money be turned over to this representative on or before 15 November 1950.
3. The subsidy shall be used to cover the expenses of publishing and distributing a newspaper for the period of four months. The first few editions will comprise 5,000 copies weekly. Distribution will be in and outside of Germany.
4. There is a sizeable supply of suitable articles and press release material already on hand for this newspaper.
5. Control of the anti-Soviet group's use of the money shall be handled initially by an OSO representative (in lieu of an OPC man) abroad who has contact with the group. The following accountability and obligations will be imposed:
 - a. The individual receipting for the money shall present a monthly financial accounting broken down into costs for:



- iii. Monies collected in various countries from subscribers.
- No b. A detailed report on the popularity of the paper in various countries and among various political groups will also be required monthly.
- No c. The monthly critique will include suggestions for improving either the form, content, or distribution of the paper.
- No d. The OPC or OSO case officer in the field shall to a limited degree have the function of consulting editor in that the publishers will have to have his approval for all major articles and editorials before these articles go to press. Specifically, the editorial policy re America, the publication of intelligence information procured from the homeland and re unity in the emigration must be made acceptable to OPC and OSO.
- No e. Newspaper space will be made available to OPC and OSO for articles provided these articles are consistent with the overall policy of the anti-Soviet group. Some articles presented for publication will be already written and will require only translation. Others will be outlined briefly to one of the native editors and the group will write the article themselves.
- No f. A responsible representative of the publishing group shall prior to receiving the subsidy sign a statement to the effect that he understands fully the obligations of his organization set forth in points "a" through "e" above and that his organization agrees to comply with OPC and OSO's pertinent regulations in all their publications whether the subsidy money was used to publish them or not. The statement prepared for his signature will contain all the main points set forth above and below plus the statement that neither the anti-Soviet group nor any Americans shall have the right to make the sense of subject matter of the publishing agreement or subsidy public in any way. All three copies of the signed statement will be retained by CIA for safe keeping with the Munich copy available for perusal by the signee on demand. The other two copies will be placed in the respective OPC and OSO case files at Headquarters.
6. Profits accrued from the sale of the newspaper shall be the property of the anti-Soviet organization so long as these profits are used for purposes which are not contrary to the interests of OPC/OSO or the United

States Government. In general it is agreed, however, that the profits shall be employed by the subsidized group on projects which directly or indirectly benefit OPC or OSO.

7. If the Newspaper is a success and is deemed worthwhile by OPC and OSO, requests for the approval of additional monthly subsidies will be made. If a subsidy for the fifth month is warranted, approval will be requested on the Friday of the second week of the fourth month.
