1. SUBJ REF IS IDEN. BORN CIRCA 1933-34 REGION KRESTONOPOL, POLAND, WHICH NOW USSR. FATHER DECEASED, MOTHER BELIEVED LIVING UNKNOWN LOCATION POLAND. SUBJ IS STUDENT FROM LUBLIN STATE UNIV, LUBLIN, POLAND WAS STUDYING OXFORD UNDER SCHOLARSHIP SINCE LATE 58 JAN 59. SINCE SCHOLARSHIP ENDED 30 SEPT 60 SUBJ NOW ON COLLEGE SPECIAL FUNDS. ALTHOUGH OF UKRAINIAN DESCENT, SUBJ ALWAYS CLAIMED POLISH DESCENT.

2. SUBJ IS CLOSE FRIEND PROF ISAI BERLIN, OXFORD AND IN CORRESPONDENCE WITH DR OLEKSA HORBACH, FRANKFURT. HORBACH MET SUBJ WARSAW 57 AND VISITED HIM OXFORD MARCH 59. SUBJ WROTE HORBACH JUNE 59 HE THINKING REMAINING OXFORD. JULY 60 SUBJ ASKED HORBACH'S ADVICE REMAINING WEST. AUG 60 SUBJ WROTE HE PROBABLY REMAIN WEST FOR GENERAL REASONS, SEPT 60 SUBJ INFORMED HORBACH HE INTENDED REMAIN WEST AND DISCLOSE REAL NATIONALITY AND INTENTIONS TO COLLEGE AUTHORITIES. ABOVE INFO RECEIVED FROM HORBACH THROUGH AECASSOWARY 29 ON 27 OCT 60.

3. HORBACH DOES NOT KNOW HOW SOON SUBJ WILL APPROACH BRITISH AUTHORITIES WITH ASSISTANCE PROF BERLIN, BUT AT 29'S SUGGESTION AGREED WRITE SUBJ ADVISING HIM REMAIN WEST OBTAIN POSITION OXFORD.

4. SINCE SUBJ MADE DECISION REMAIN WEST BELIEVE IMMEDIATE OPS POTENTIAL NOT NOW PRESENT. SUBJ PROBABLY KNOWLEDGEABLE OTHER UKRAINIAN STUDENTS LUBLIN STATE UNIV WHICH MAY HAVE OPS POTENTIAL FUTURE. SUBJ ALREADY IN CORRESPONDENCE AECASSOWARY SYMPATHIZERS AND APPARENTLY DESIRES CONTINUE THIS ASSOCIATION.
