CS COMMENT: *STATED SMOTH INVOLVEMENT WITH SHPORLIUK, DEFECTOR, UNKNOWN.

1. SHPORLIUK WROTE HORBACH 24 NOV BRITISH HOME OFFICE AGREED EXTEND VISA SIX MONTHS BEYOND 30 NOV ALTHOUGH ORIGINALLY REFUSED EXTENSION. PROF BERLIN ATTEMPTING LOCATE JOB FOR SHPORLIUK, BUT FEELS CHANCES SLIM.

2. LETTER CONTENTS: SHPORLIUK DESIRES OBTAIN SCHOLARSHIP AND VISA FOR TRAVEL STUDY PBPRIME SINCE FEELS OVEROBLIGATED COLLEGE FOR TWO YERAS SUPPORT. WANTS OBTAIN PERMISSION POLISH EMBASSY LOND TO TRAVEL PBPRIME, BUT WILL REMAIN WEST AS STATELESS PERSON AND PERHAPS IMMIGRATE PBPRIME OR CANADA IF PERMISSION NOT GRANTED.

3. SHPORLIUK DOES NOT STATE IF POLISH AUTHORITIES KNOW HIS INTENTIONS, BUT HORBACH WILL WRITE AGAIN. SHPORLIUK CANNOT VISIT GERMANY NOW AND PERSONAL CONTACT THUS IMPOSSIBLE UNLESS AECASSOWARY 29 TRAVELS ENGLAND UNDER HIS AEBEEHIVE COVER FOR NON-OPERATIONAL PERSONAL MEETING IN ORDER TO CLARIFY SITUATION. HORBACH WROTE SHPORLIUK SUCH VISIT MIGHT TAKE PLACE. PLEASE ADVISE.

4. AEBEEHIVE IS IDEN AND PUBLISHED TWO SHORT ARTICLES WRITTEN BY SHPORLIUK.
