1. DOES NOT HAVE ENOUGH BACKGROUND KNOWLEDGE AECASSOWARY-29, AEBEEHIVE, OR SHPORLIUK TO MAKE DECISION WHETHER SUCH CONTACT WOULD BE WORTH RISK INVOLVED. CAN AECASSOWARY-29 COVER STAND UP TO DIRECT JAGUAR/SMOTH INVESTIGATION SHOULD HE COME THEIR ATTENTION WHEN MAKING CONTACT? PERHAPS MORE IMPORTANT, SHPORLIUK IS SUBJECT TO DIRECT INTERROGATION BY JAGUAR SHOULD ANY SUSPICIOUS CONTACTS, OR CORRESPONDENCE, COME TO THEIR ATTENTION. AT END OF SIX MONTHS, WHEN HIS VISA UP FOR RENEWAL PERMISSION TO EXTEND WILL HINGE IN LARGE PART ON HAVING COMPLETELY CLEAN RECORD OR BEING ABLE TO EXPLAIN TO AUTHORITIES ANY QUESTIONS THAT MIGHT HAVE COME UP DURING HIS STAY HERE. WOULD SHPORLIUK BE ABLE TO SATISFACTORILY EXPLAIN AECASSOWAY-29 CONTACT IF ASKED

2. IMPRESSION IS THAT THERE NOT VERY CLEAR IDEA WHETHER SHPORLIUK HAS ANY REAL OPS POTENTIAL OR HOW HE WOULD BE USED IF HE DID. AS LONG AS HE IN U K OR IF HE REQUESTS PERMISSION STAY IN U K WE EVENTUALLY WOULD HAVE TO DISCUSS WITH SMOOTHERS. CERTAINLY, IN SMOOTHER EYES, THE TYPE OF ELICITATION OR "DISCREET" OPS DISCUSSION PROPOSED WOULD BE CLOSE TO DIRECT BREACH BY KUBARK OF UNDERSTANDING RE UNILATERAL OPS.

3. QUESTIONS WHETHER WE STAND TO GAIN MORE BY PROCEEDING PER REF THAN TO DISCUSS POSSIBILITIES OPS EXPLOITATION OF SHPORLIUK WITH SMOTH AND CONSIDER CLEARING OP AT THIS STAGE OF GAME.

4. HOWEVER, IF HQS BELIEVES AECASSOWARY-29/SHPORLIUK CONTACT CAN STAND UP JAGUAR SCRUTINY AND IF THEY CONSIDER POTENTIAL OPS USE OF SHPORLIUK WORTH CLEAR RISKS INVOLVED, WILL DEFER HQS DECISION.
