1. PER AECASSAWARY/29, INFO IN PARA ONE BASICALLY CORRECT.

UKRAINSKA SALLSKAPET WAS INDEPENDENT OF POLITICAL GROUPS AND FOUGHT ~~BACK~~ IN 1948 WHEN KENTRZYNSKYJ FNU, MELNYK GROUP MEMBER AND UNC REP IN SWEDEN, TRIED SUBORDINATE FEDORCHUK (F) GROUP TO UNC. F WON LIABLE SUIT AGAINST KENTRZYNSKYJ IN SWEDISH COURTS. F DOES NOT BELONG TO ANY POLITICAL PARTY BUT IS SYMPATHIZER OF AECASSAWARIES. F SEPARATED FROM WIFE WHO TWENTY YEARS OLDER THAN HE.

2. A/29 PLANS MEET WITH A/34 AND DISCUSS F CASE. HE DOES NOT PLAN MEET F PERSONALLY UNLESS OPERATIONALLY NECESSARY. [] AND A/29 AGREE GO SLOWLY AND CAREFULLY ON THIS OP. IF A/29 DOES NOT MEET HIM, F WILL ONLY THINK HE DOING PERSONAL FAVOR FOR A/34 WHO NOT KNOWN TO BE WORKING COVERTLY FOR AECASSAWARIES.

3. ADDITIONAL BIO DATA: F WAS IN POLISH NAVY IN LATE THIRTIES. WENT TO SWEDEN IN 1938 OR 39. HAS IN PAST YEARS BEEN ON SHORE LEAVE SEVERAL TIMES IN ODESSA.
