1. It was of considerable interest to have had a source who talked to someone who travelled in the Soviet Union right at the height of the Cuban Crises, i.e., starting with the date of Kennedy's ultimatum on the 22nd to Khrushchev's capitulation on the 28th.

2. In view of the fact AECASSOWARY/29 may not be returning to Brussels, we realize you have no access to the source to press for additional details, if any. However, in the event similar information is obtained from other sources, it would be useful if precise dates could be obtained and comments as to what specifically was heard on the radio, for instance, during such periods.

3. We are sorry about the late date of this acknowledgment, but comments were being awaited from the interested parties.
