1. Reply to Reference has been delayed because the subject required more than the ordinary amount of cross-checking. Because of the nature of the sponsor, we desired to check our possible interest or involvement through our various contacts among refugee groups in Buenos Aires. We finally found they were not concerned with the magazine. However, it developed that the local promoters of this publication were in contact with [ ] K UWOLF. It also developed that the promoters of "Prólogo" were in contact with [ ]. We now believe that we have sorted out the situation and are able to make a judgment.

2. In general, we agree with the opinion of the Buenos Aires Headquarters desk that this magazine is of marginal interest to us. Specifically, in addition to the comments made by the desk, an examination of the content of the magazine convinces us that it is a thoroughly militant right-wing Catholic Action publication. There is a sufficient quantity of such propaganda material available in Buenos Aires.

3. There are also complications. Among the items accounted for by [ ] K UWOLF when the final accounting for our support to the university campaign was made by them was the indication that some of our funds were spent in support of "Prólogo." [ ] K UWOLF believed the magazine useful when it was necessary to mount a considerable volume of propaganda in the university election campaign. However, they have no interest in a continuing subsidy. This possibly accounts for the appeal through [ ], which group also maintains contact with


