1. Para. 3 of reference states that AECASSOWARY/29 financial information was being pouched. In view of para 2.d., in OBBW-8496, 4 June 1962, where it is stated that A/29 would account to the station for his travel and operational expenses, it is not clear just what will be forthcoming. Please check the following references in which you were notified of allocations for A/29 activities.

- a. DIR-13901, 31 May: Para. 3 stated that cost center authorization was being transferred to [ ] in OBBW-8496.
- b. OBBW-8496, 4 June 1962: Informed that [ ] was being transferred to [ ] for the remainder of FY-1962 under allotment 2134-4008-5995.
- c. DIR-23709, 17 July: Initial allocation for FY-63, [ ] charged to allotment No. 3134-4008-8094.
- d. DIR-26187, 27 July 1962: Additional [ ] transferred.

2. After his return to the United States, A/29 submitted an accounting for the period 21 January through 28 January 1963. Before an accounting for this amount can be made at headquarters, it is necessary to know whether or not any of A/29's advances made in the field are still outstanding against which this amount should be credited or whether he should be reimbursed for the amount he expended during the period mentioned. Since A/29 has been so meticulous about his records of operational expenditures at headquarters, we should like every effort made to keep his records in good order. Your early comments on the present state of AERODYNAMIC financial records in [ ] will be appreciated.
