Our specific relationship with the group - i.e., the question of how closely we must supervise its operations - is under review. The Project must, after the review is complete, be amended, for the original statement of objectives is no longer valid, and does not reflect present thinking. *The project will be reviewed and redocumentation submitted by 1 October 1956 (per [ ] C/SR/PP, 6/19/56.)*
