<b>a) By Field</b>								
1. The publication of the Ukrainian newspapers is being continued and the added circulation is mailed to the USSR for the purpose of propoganda and information. In addition, an information bulletin produced by Prolog Associates will be mailed to the USSR from the Field.								
<b>b) By Headquarters</b>								
1. The first information bulletin of the UHVR has been produced by Prolog Associates and will be distributed by them through their representatives all over the world for the purpose of mailing to the USSR.								
2. The reorganization of Prolog Associates as a research and publishing house has been completed and the administrative plan has been worked out to take care of the activities and expenditures of the organization.								
3. In connection with the new administrative plan and centralization of direction of all political activities in New York, AECASSOWARY 2 has been authorized to take a trip to Europe to reorganize and adjust the operations of the group in that area.								
4. Broadcasts through PYREX are continuing on the same schedule.								
5. Public meetings throughout the U.S. and Canada to express indignation of the Ukrainian population against Soviet brutalities will be continued for another month.								
6. The Ukrainian broadcasts through Radio Nacional in Madrid are guided and directed by Prolog Associates in New York.								
7. The Ukrainian emigres in Australia are continuing their activities regarding distribution of Russian and Ukrainian books to the Soviet personnel and tourists in Australia.								
8. The Argentinian representatives of Prolog Associates are submitting general information reports regarding the Soviet activities in Buenos Aires.
