

MEMORANDUM FOR RECORD

SUBJECT: 19 July 1965 Contact with AECASSOWARY/29 in Washington

The meeting was held at A/29's request who said he had the report of his debriefing of Vera Vovk ready and did not wish to send it by mail. The meeting was held in the safe office used by SR/CA.

1. A/29 turned over his report on Vovk's trip to the USSR and we discussed the highlights of her experiences. After her meeting with A/29 in Vienna she was to leave for the P.E.N. Congress in Bled and a short vacation in Yugoslavia. She was planning to spend several weeks in Europe before returning to Brazil, probably via the United States at which time A/29 will again have an opportunity to talk with her personally.

2. A letter/dated 28 June 1965 was delivered to Dr. KLACHKO by TOLOPKO in New York who said it was brought to him by friends of his who had visited in Kiev. There is nothing very significant in the letter. LEVISCHENKO again invites KLACHKO to visit Kiev where she can talk in person with prominent Ukrainians. A copy of the letter is in KLACHKO's and LEVISCHENKO files.

3. KLACHKO also had a letter from YAREMKO of Chicago who is visiting in the USSR. The letter dated 28 June was mailed from Kiev. KLACHKO had told him she would be interested in obtaining a Ukrainian rug for her apartment. YAREMKO writes that the rugs are rather expensive and that if she is really interested in having one she should write to C. KOLOSOVA asking for one. YAREMKO states he is going on to Moscow and Lvov and back to Kiev before returning to the United States on about 23 July at which time he hoped to see her.

4. Christine WOLYNETS (of Cleveland. Visited in USSR) told Olga HANETSKA ~~XXXXXXXX~~ to convey to A/29 the following: M. STEPANYAK was having many family problems because of his own and his mother-in-law's illness; that although he is not being given employment, there is all sorts of respect for him in Kiev; <sup>V.</sup>KUK has a job but enjoys little respect in official circles; Christine visited Dr. Mykola TYMCHYSHYN (his wife lives in Cleveland and is a sister to Ol'ha HANETSKA) in Lvov. He and his sister are planning to see STEPANYAK and convey to him everything Christine told him and that STEPANYAK would probably write to someone in the emigration. HANETS'KA further states that Christine, Tamara TYMCHYSHYN and her mother (wife of Mykola) are planning a trip to Poland this summer and will probably meet with Dr. TYMCHYSHEN there.
