Pravda's comments on Alla Grigoryevna BONDAR are based on an affair we consider of domestic interest only, not of sufficient interest to a non-Soviet audience to justify planting it abroad. BONDAR's action at the festival of song can be defended on the basis of a desire to recognize and encourage a greater number of the participants at the festival. It is, therefore, considered unlikely that a story in which she is presented as an official under Soviet public degradation would seriously affect her prestige in Teheran. BONDAR does not enjoy great popularity with the Soviet Ukrainian public but so far as we can judge, her prestige in official circles has not suffered to date.
