MEMORANDUM FOR: Deputy Director for Plans**SUBJECT: Ukrainian Refugees**

1. Attached is a copy of a memorandum from the Soviet Bloc Division concerning a quarrel in Ukrainian refugee circles between Dr. Lev Dobriansky, who is a member of the faculty at Georgetown University, and Prolog Research and Publishing Association, Inc., the Ukrainian refugee outfit supported by the Agency.
2. From what we know now, it does not appear too likely that this will become a matter for lawsuits; we believe the "flap potential", if any, lies in congressional action. The Legislative Counsel informs us that Dr. Dobriansky is well known to Representative Michael A. Feighan, who is Chairman, Immigration Subcommittee, House Committee on Judiciary, and who is a very difficult and unpredictable person. This is also the type of situation in which Representative John E. Moss would probably take a lively interest.
3. I have no particular recommendation, as I am not knowledgeable of the operational potential of Prolog, but I invite your attention in view of the concern expressed by the Director, at the time he was briefed on the Heine v Raus case, about refugee operations in the United States.
