Currently, the safehouse used by AECASSOWARY 3 and 6 (see property O-14 as listed in EGMA-33324 of 17 April 1958) is being paid for by [ ] Under [ ] requirements, safehouses covered by [ ] are required to be multi-purpose facilities and must not be used exclusively by any one project. Until recently, with property O-14 being used by AECARTHAGE, AERODYNAMIC and [ ], [ ] requirements were adhered to; however, with the elimination of this property's use by [ ] and the cancellation of the AECARTHAGE Project, only AERODYNAMIC continues to use O-14 which, of course, means that funds for it will no longer be forthcoming from [ ] unless other projects are moved in.

2. The property in question could be carried by [ ] to be used in CE cases as necessary, but because of the nature of the past use of this safehouse this has been ruled out as impractical and insecure. Furthermore, AERODYNAMIC activities are not quite in the [ ] field, which is still another reason why this safehouse can not properly be charged to that project, especially when [ ] funds could be better used for strictly [ ] business. We find, however, that a safehouse for AERODYNAMIC is desirable for meeting with AECASSOWARY 3 and 6, and a safehouse also provides AECASSOWARY 3 and 6 private facilities for working on certain AERODYNAMIC activities. It provides a home for AECASSOWARY 6 and serves as a headquarters for visiting AERODYNAMIC personnel as for example AECASSOWARY 2.

3. We request, therefore, that if headquarters is as anxious as we are to maintain property O-14 for project AERODYNAMIC, that funds for it be provided and arrangements made to transfer these funds to CAUDO since we would prefer that [ ] continue caring for property O-14 as this would eliminate local bookkeeping problems.
