1. The referenced dispatch is a request addressed to the SR Division to extend the Brussels assignment of AE/29 to 1 January 1964, and to commit approximately \$4650 of new funds to support this extension during Fiscal 64.

2. The purpose of the instant dispatch is to call this case to the special attention of Chiefs, WE and WE/2.

3. The case for the permanent assignment of a native Soviet specialist in Brussels has merit and it is believed that the Division endorses it in principle unreservedly. Our Related Mission Directive lists Soviet targets as our highest priorities. In order to support the Soviet portion of our program we must have at hand and under our immediate control a native expertise in Soviet matters. The undersigned is fully aware that he could call for such expertise from other stations in the area. But that facility is only a stop-gap measure to care for emergencies. Station needs a residing expert who is familiar with the area surroundings, with the milieu frequented here by Soviets and with local security practice, and who by frequent exchanges with Station's case officers working on Soviet targets stimulates their thinking and can check their errors or omissions.

4. Specifically as regards the assignment of AE/29 for the functions described above, Station wishes to stress that it is well satisfied with his manner of performance to date. From an operational management and administrative support point of view he has been most cooperative. Furthermore, he is by now well integrated in the local scene which is an important consideration. He has been fully accepted by the [ ]s who are backstopping his presence administratively and by the communities in which he operates. The undersigned is naturally aware of the limitations imposed on Subject's use as regards highly sensitive material but such limitations still leave a very considerable field available for his use.
