SUBJECT: Bunker I/B-P/5 in Munich

A. General Information on the Bunker

1. Bunker I/B-P/5 was established by the Prague Baza, III/B/C/M, whose political section directs its activity through its head Major PETROV, Pod-Lipkami, Praha. The Centrum of the Bunker is in Munich but it is directly controlled and has direct communications with Major PETROV in Prague. A courier between Bunker I/B-P/5 and its Baza, one Ivan PALKANENEC, lives in Mittenwald and crosses the Czech-Bavarian border illegally between Sell, Bavaria, and Asch, Czechoslovakia.

2. Bunker I/B-P/5 maintains contact with other Bunkri in Bavaria, especially with the Munich Military Bunker, ?/?-G/12. The chief of this latter bunker is Lt. GARCEL, a Czech liaison officer in Munich, living at Corneliusstrasse 30/II, Munich. Through Lt. GARCEL, Bunker I/B-P/5 maintains liaison with the chief of the Regensburg Bunker, ?/?-B/9, BUDINSKI (a Czech liaison officer in Regensburg), and with Lt. (?) FEDOROV, a Russian Repatriation officer in Regensburg. Bunker I/B-P/5 also has a contact with the Frankfurt Bunker ?/?-Ja/9, whose chief is JANOVSEK, Czech liaison officer in Frankfurt.

3. Bunker I/B-P/5 is divided into several Bunki, located in various cities in the American Zone. The known Bunki include:

- a. Munich Bunka CH/1, headed by Jurko CEIMYNEC, Feilitechstrasse 47, living with a family named KARAS, a Ukrainian Red Cross worker.
- b. Frankfurt Bunka P/03
- c. Bayreuth Bunka D/23, headed by Petro BUDTCHUK
- d. Ansbach Bunka G/16, headed by Fedio GABRIL.
- e. Mittenwald Bunka F/2, headed by Mychailo FENTCHAK.

Other Bunki of Bunker I/B-P/5 are known to exist in Ulm, Augsburg, and Aschaffenburg, and even in Braunschweig (British Zone).

4. The agents of Bunker I/B-P/5 and its subordinate Bunki are mostly Carpatho-Ukrainians recruited in Czechoslovakia and sent illegally through the border about 7 to 8 months ago.
