MEMORANDUM FOR THE RECORD

SUBJECT : Contact with AECASSOWARY-15 on 17 January 1957.

1. Contact was made with Subject in his home by [ ] and [ ] about 1145 hours on 17 January 1957. The purpose of the meeting was to pick up the list of addressors for the package program which AECASSOWARY-2 mailed to Subject and to answer a number of questions Subject raised about the Hot War recruitment program.

2. Subject turned over a list of 11 addressors for Project AECUP-BOARD which he received from AECASSOWARY-2, and read excerpts of a letter received along with the addressor list in which AECASSOWARY-2 explained that some of the names submitted will be fictitious, although the addresses shown are true addresses.

3. Subject had a list of questions submitted by AECASSOWARY-2 on Hot War recruitment pertaining to reemployment rights, United States Military Service obligations, leaves of absence from schools, expenses, etc. His questions all were answered by [ ], with the exception of one question regarding ROTC training; i. e., if an individual is a member of the ROTC can he become a candidate for the Hot War cadre and how can his ROTC training be handled? Subject was told by [ ] that he would be in touch with him again as soon as a solution to this question is determined.

4. Regarding ~~L~~ ORTYNSKY, Subject stated that his medical examinations at the sanatorium in North Dakota have been completed and the results have been forwarded to Washington. He did not know to whom the results were sent and inquired whether we could determine where they were. He stated that the medical examinations showed ORTYNSKY to be in good health and that all that remains now is for the Agency to contact him and determine whether he is suitable as a spotter and/or an instructor for the Hot War program. [ ] promised to follow up the matter and notify AECASSOWARY-2 of the results.

5. Subject stated that one fnu ~~MICHAL~~'UK, a sergeant at Fort Meade, circa 30 years of age, who is a career army man and who had been a member of the Ukrainian First Division HALYCHYNA would be a willing candidate for the Hot War cadre. He suggested that perhaps MICHAL'UK could be utilized in an instructor capacity.

6. Subject stated that AECASSOWARY-2 was planning to go to Canada on Friday, 18 January, and wanted to know whether it would be possible to have an advance for the package program in order to start the package mailing. Subject was told that it was doubtful that any money could be secured on such short notice but that he would be telephoned later in the day about a definite answer. (Subject was telephoned 1530 hours, 17 January, and told that it was not possible to secure an advance for AECASSOWARY-2 at this time.)

7. Subject was told that as soon as the addressor list of names had been cleared, he and AECASSOWARY-2 would be notified, so that the mailing of packages could begin as soon as possible. Subject stated they would wait for our instructions in this regard.

8. AECASSOWARY-2 requested Subject to obtain the name and complete address of AECARTHAGE-12's last contact point in the Ukrainian SSR. This individual is being used as an addressee for packages under the AECUPBOARD Project.   promised to make this available.   personally delivered the information to Subject on 18 January 1957.)

9. The meeting was terminated at 1230 hours. No date was set for the next meeting.
