dated 16 May 1969

1. With reference to the Audit Staff's recommendation in paragraph 5 the balance in the Swiss bank account was reflected on the Statement of Cash Receipts and Disbursements for the period ending 31 March 1969, transmitted to the Office of Finance on 13 May 1969, and will be reflected in the fourth-quarter report for the period ending 30 June. Swiss bank statements are issued irregularly. We prefer that AETENURE not draw attention to itself by making a special request for verification of its balance at this time. However, we plan to close the Swiss account early in fiscal year 1970 as part of a revision in the AETENURE/AETERRACE funding arrangement. The account balance will be confirmed then.

2. Pursuant to paragraph 6 of the reference, the cleared New York attorney has been requested to forward the stock certificates, which will be endorsed in blank by all the ostensible stockholders and forwarded to the Office of Finance. This office was advised on 6 May by [ OGC, that Declarations of Trust for the stock certificates are not necessary and need not be obtained and forwarded to the Office of Finance as required by the project Administrative Plan. Therefore no action will be taken to secure the Declarations.
