IMMEDIATE ACTION

RE: MUNI 2915 (IN 10824)

1. 12 JAN FOLL FROM AECASS 3, SUBSOURCE AECAVATINA 5, RE SKOB DISAPPEARANCE:

A. BORIS SKOB AKA VOLODYMYR KUROVETS, DOCUMENTED GB IN FALSE NAME, ARRIVED MUNI 7 JAN WITH FNU ZHURKO, (ALSO RECEIVED ZHURKA) AKA FNU VASYL KO. SKOB WAS SEEN MUNI 7 JAN BY SMOTH REP (NU). 8 JAN SKOB REQUESTED MEET VASYL SKOLOZDRA (AECAV 1 BODYGUARD); ALSO MET KEROD, KAMINSKY, (ALSO RECEIVED KAMINSKY), ANDRIYEVSKYY. EVENING 8 JAN SKOB VISITED SKOLOZDRA IN PRIVATE WHERE ALSO MET ZENON ZBROZHEK- GAJOCHA HAYOKHA (ALSO AECAV 1 ADHERENT). SKOB RETURNED AECAV 5 RESIDENCE 2230 JAN 8.

B. EARLY 9 JAN SKOB, DRESSED IN BLACK SUIT, WHITE SHIRT AND BLACK SHOES (ALL BRAND NEW), LEFT AECAV 5 RESIDENCE ALLEGEDLY IN ORDER VISIT AECAV 1 OFFICES. MEANTIME ZBROZHEK AND SKOLOZDRA ATTRACTED ATTN SELF AT CHURCH BY ARRIVING BY TAXI OSTENSIBLY LOOKING FOR SKOB, DEPARTED BY TAXI WITHOUT SKOB TO INGOLSTADT STATING WOULD BE GONE SEVERAL DAYS. (KASHUBA HAD DEPARTED MUNI 6 JAN.)

C. SKOB ABSENCE NOTED ONLY NOON 10 JAN WHICH DULY REPORTED SMOTH REP BY ZHURKO. SMOTH REP PROMISED NOTIFY HQS IN ORDER OBTAIN ASSIST GERMAN AUTHORITIES.

ZHURKO PHONED LENKAVSKYY RE SKOB; LATTER BECAME CONFUSED AND INITIALLY REFUSED ANSWER, ASKED BE CALLED BACK (LATER L DENIED ANY KNOWLEDGE WHERE ABOUTS SKOB).

D. 11 JAN LENKAVSKYY AND STEPAN MUDRYK (SB MAN FROM NEU ULM) ACCUSED AECAV 5, SMOTH, AECASS 1 AND AIS OF LIQUIDATING SKOB; FORMER DEMANDED THAT MATTER BE INVESTIGATED BY MUDRYK AND KEROD WHO AGREED THIS. INVESTIGATION CEASED WHEN MUDRYK DEMANDED INTERROGATE AECAV 5 AND WIFE. EVE 11 JAN AECAV 5 REPORTED MATTER MUNI POLICE. (DIR PLS PROVIDE GUIDANCE RE DESIRED MOB RESPONSE TO EVENTUAL LFV INQUIRY.)

E. ON DISAPPEARANCE, SKOB HAD 8 POUNDS, 180 DM; ALSO TOOK ELECTRIC RAZOR.

F. 5 BELIEVES SKOB TAKEN, VOLUNTARILY OR OTHERWISE, BY AECAV 1 ORGANIZATION.

2. INTERESTING SIDELIGHT IS AECAPELIN 12 JAN INFO THAT ~~6 JAN INFO THAT~~ 6 JAN KASHUBA TOLD HE GOING NEU ULM FOR CIRCA 1 WEEK IN ORDER CONFER WITH MUDRYK; 12 JAN HAD NOT RETURNED (SEE PARA 1D ABOVE).

3. VIEW WHAT APPEARS INTENTIONAL ATTEMPT BY ZBROZHEK, SKOLOZDRA AND KASHUBA BUILD ALIBS, LENKAVSKYY CONDUCT AND AECAVATINA 1 ATTEMPT COMPROMISE AEDRUMMER 1 (AND AECASS 1 AND SMOTH), AECASS 3 BELIEVES, CONTRARY ORIGINAL IMPRESSIONS PARA 2 REF, THAT SKOB IN HANDS AECAV 1.

4. AECASS 3 AND AECAV 5 FEEL THAT SKOB, IF NOT ABDUCTED BY AECAV 1, TRANSFERRED LOYALTY TO AECAV 1 SINCE HAD BEEN TOLD BY SMOTH THAT HE DISTRUSTED. EITHER WAY FEEL SECURITY AECARTHAGE 5 AND 20 OPS AT STAKE. (3 AND 6 ALSO SUSPECT ZBROZHEK AND SKOB OF COLLUSION SINCE BOTH SUSPECTED OF RIS COLLABORATION.)
