PLS ADVISE SMOTH FOLLOWING:

A. KUBARK INTEREST SKOB DISAPPEARANCE OVERRIDINGLY FOCUSED ON SECURITY AECARTHAGE 19 AND 20 OP, BREACH OF WHICH NOT EXPECTED ON PART OF SMOTH IN VIEW PPRIME MEET WHEREIN SMOTH AGREED "IF AFTER CONFRONTATION AND INTERROGATION SKOB APPEARS CLEAN SMOTH UNDERTAKE NOT TO EXPLOIT SKOB UNTIL OUTCOME OF 20 OP BECOMES KNOWN TO KUBARK, THAT IS, UNTIL 1 SEPT 55 OR UNTIL SUCH EARLIER DATE AS KUBARK MAY BE ABLE GIVE CLEARANCE. FURTHER, IN ORDER PROTECT CURRENT 20 OP SMOTH UNDERTAKES, AFTER CONFRONTATION, TO KEEP ~~SKOB~~ SKOB IN CIRCUMSTANCES DENYING HIM ALL OPPORTUNITY COMMUNICATING WITH RIS UNTIL OUTCOME 20 OP BECOMES KNOWN KUBARK."

B. AFTER [] [] PROTESTED UNAUTHORIZED DISCLOSURE TO SKOB AT CONFRONTATION THAT AECARTHAGE 19 HAD BEEN UNDER HIS CONTROL, SMOTH STATED SKOB WOULD NOT BE EXPLOITED AND NOTHING WOULD BE DONE TO COMPROMISE 20 OP. FURTHERMORE, SMOTH GAVE ASSURANCE SKOB TO BE RESETTLED IN CANADA.
