1. PLS NOTE EGMA 19136 (FORWARDED 2 FEB) FOR AECASS 3 REPORT RE AVAILABILITY CANDIDATES SMOOTHERLAND FOR REDSOX PROGRAM.

2. FOLL ACTION TAKEN BY AECASS 3 TO DATE:

A. IN LINE APPARENTLY SUITABLE OP CLIMATE SMOOTHERLAND, AECASS 3 INSTRUCTED ROMAN IL'NYTSKY Y VISIT SMOOTHERLAND ASCERTAIN MORE PRECISELY WHO AVAILABLE. TRIP OSTENSIBLY BEING MADE FOR PURPOSES ACQUAINTING AEDRUMMER 1 SUPPORTERS WITH RECENT REORGANIZATION AEDRUMMER 1 (IL'NYTSKY Y MEMBER OF AEDRUMMER 1 PJLITRADE). CURRENTLY PROCESSING FOR SMOTHERLAND VISA. VASYL'KO AKA ZHURKO CURRENTLY VISITING VARIOUS UKE CENTERS (PORTION GARBLED BEING SERVICED) SURVEY AND WILL THEN ASSIST IL'NYTSKY Y.

B. VOLODYMYR STAKHIV, NOW PROCESSING FOR VISAS, WILL VISIT UKE CONCENTRATIONS BELGIUM, HOLLAND AND FRANCE. IF ABLE OBTAIN ASSISTANCE DR VASYL MARKYS', WHO PARIS RESIDENT AND ACTIVE UKE YOUTH CIRCLES FRANCE AND SPAIN, WILL ALSO VISIT SPAIN WITH MARKYS'.

C. CONSIDERING VARIOUS POSSIBILITIES FOR CONDUCTING GENERAL SURVEY UKE CENTERS WEST GERMANY AECASS 3'S CONTACT IN UKE LABOR SERVICE CO NOW EMIGRATED PBPRIME, HENCE NO CURRENT ACCESS. PL 497 WILL BE ASKED ASSIST STAKHIV IN GERMANY.

3. AECASS 3 HAS NO REDSOX CANDIDATES CURRENTLY AVAILABLE OR MATERIAL FOR TRANSMITTAL TO AECASS 2.

4. GENERALLY OUR FEELING THERE EXISTS IN WEST GERMANY AND OTHER EMIGRE CONCENTRATIONS EUROPEAN COUNTRIES CERTAIN RESERVOIR SUITABLE REDSOX CANDIDATES. TAPPING THIS RESERVOIR WOULD HOWEVER REQUIRE INTENSIVE SPOTTING AND ASSESSMENT EFFORT NECESSITATING ASSIGNMENT ONE OR SEVERAL FULL TIME REDSOX CASE OFFICERS. MOB FULLY PREPARED RENDER ANY ASSISTANCE IN STARTING SUCH PROGRAM, HOWEVER UNABLE MAKE AVAILABLE CASE OFFICERS ON OTHER THAN PARTTIME BASIS; BELIEVE ONE EXPERIENCED REDSOX CASE OFFICER ASSIGNED THIS PROGRAM COULD ACCOMPLISH MUCH WITH MOB SUPPORT AND ON BASIS ALREADY EXISTING SPOTTING FACILITIES (IN UKE FIELD THRU AECASS 3 IN RUSSIAN THRU [] AND PERSHAN AND POSSIBLY THRU AECAMBISTAS IN BYELO FIELD). MOB PREPARED CARRY ON PRELIMINARY ORGANIZATIONAL AND LIMITED SPOTTING WORK OVER NEXT FEW MONTHS WITH UNDERSTANDING THAT POSITIVE DECISION RE ASSIGNMENT CASE OFFICER (S) BE MADE SOONEST AND THAT IN MEANTIME CONTINUOUS GUIDANCE RE SPOTTING AND RECRUITMENT POLICIES BE PROVIDED BY HQS.

5. IN LINE WITH ABOVE AND CONTRARY TO PARA 4 REF B, HAVE EXTENDED []'S EMPLOYMENT UNTIL 15 APR. WISH EMPHASIZE HOWEVER THAT WITH PRESENT WORK LOAD WE UNABLE DO MORE THAN SUPERVISE SPOTTING AND SUBJECT CANDIDATES PRELIMINARY ASSESSMENT; IT IMPERATIVE FOR CONTINUITY OPERATION THAT WE ABLE TAKE OVER SUITABLE CANDIDATES FOR FULL ASSESSMENT PROCEDURES.
