1. AFTER 11 MAY AECAVATINA 1 AECAVATINA 12 MEETING, LATER VISITED AECAPELIN WITH NEWS OF AECAVATINA 1 RECEIPT OF S/W LETTER FROM AECAVATINA 11 CIRCA EARLY MAY. CONTENTS LETTER FOLL:

- A. STATUS OUN IN HOMELAND.
- B. REQUEST FOR COURIERS, W/T SETS, MONEY AND MEDICAL SUPPLIES.
- C. LIST NAMES AND ADDRESSES, CONTACT ARRANGEMENTS AND CODES FOR RECEPTION COURIERS.
- D. NOTIFICATION THAT EXISTING W/T SETS IN ORDER AND WILL SEND DURING MAY AND JUNE 56.

2. CONTENTS OF LETTER ONLY GENERALLY GIVEN BY AECAVATINA 12 BUT AECAPELIN FELT IT INOPPORTUNE TIME PRESS FOR DETAILS, ESPECIALLY RE PARA 1, C, D, ABOVE. (COMMENT: ASSUME IF AECAVATINA 11 TO SEND VIA W/T, SMOTH TO RECEIVE. SUGGEST, THEREFORE, SMOTH BE ALERTED IN EVENT THEY NO LONGER MONITORING AECAVATINA 11.

3. PRIMARY REASON AECAVATINA 12 INFORMED AECAPELIN RE LETTER WAS SOLICIT HIS AID IN APPROACHING AIS FOR SUPPORT AECAVATINA 1 OPS, FOR AECAVATINA 1

INSTRUCTED AECAVATINA 12 SEEK AIS SUPPORT EQUIP AND DISPATCH TO HOMETLAND. 10-12 ALREADY TRAINED AND AVAILABLE OPERATORS. AECAVATINA 12 SUGGESTED AECAPELIN'S GERMAN CONTACTS COULD FACILITATE THIS AIS APPROACH. AECAPELIN REPLIED HIS ONLY GERMAN CONTACT COLY SCHMALSCHLAEGER. HE FABRICATED, HOWEVER, THAT SCHMALSCHLAEGER FRIEND FORMER BAVARIAN JUSTICE MINISTER, JOSEPH MUELLER, WHO MAY HAVE CONTACT WITH AMERICANS. AECAPELIN TO LET AECAVATINA 12 KNOW HOW HE MAKES OUT.

4. 9 MAY [] BROUGHT UP QUESTION WITH [] WHAT TO DO RE AECAVATINA 1. HE STATED AECAVATINA 1 SHOULD BE FORBIDDEN OPERATE ON OWN IN INTEL FIELD, DISPATCH AGENTS ABROAD. [] VOLUNTEERED THAT RECENTLY HE TRIED "SELL" AECAVATINA 1 ORG TO UPSWING. THIS RESULTED IN THREE CONFERENCES WITH AECAVATINA 1 ORG, TWO OF WHICH ATTENDED BY AECAVATINA 1. AT FIRST MEET UPSWING TOLD AECAVATINA 1 THEY HAD TO CHECK MATTER WITH WASH AND AT THIRD MEET DECLARED THEY RECEIVED INSTRUCTIONS DESIST FROM OPS AGREEMENTS WITH AECAVATINA 1. AT MORE RECENT []-AECAVATINA 1 MEET, LATTER STATED AECAVATINA 1 ORG NOW CONVINCED AMERICANS WIELD GREAT POWER AND IT APPARENT COLLABORATION WITH THEM (AIS) MUST BE CONSIDERED. [] MENTIONED TWO INSTANCES CITED BY AECAVATINA 1 CONTACT AS PROOF OF AMERICAN OMNIPOTENCE, I.E., FACT UPSWING MENTIONED WASH AND AFFAIR OF THREE UKES INVOLVED IN GULAI CASE WHEREIN AECAVATINA 1 REP TRIED UNSUCCESSFULLY SWAY U.S. PRISON OFFICER TO CLEMENCY. [] INTIMATED HE INTERESTED KNOW IF AIS MIGHT CONSIDER SUPPORT OF AECAVATINA 1, AND SUGGESTED THIS POSSIBILITY.
