



MEMORANDUM FOR: Chief, FI Plans

SUBJECT : Project AEGIDEON/AENOBLE

1. The AEGIDEON/AENOBLE project expires on 31 August 1958.
2. There are several questions and problems bearing on the future plans of AENOBLE and its relationship to the parent PP project, AEGIDEON, which could not be resolved through correspondence, and which will be settled shortly by conference between field and Headquarters case officers. Therefore, we are unable to submit the AENOBLE project outline for renewal at the present time. We will take the appropriate action on Project AENOBLE as soon as possible after these problems are resolved.
3. There are no financial commitments which must be met, and no operational expenses are anticipated during the interim; therefore, no allocation of funds is necessary.
